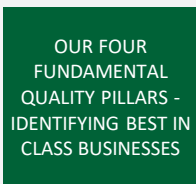

FUND OBJECTIVE

The aim is to maximise investor total return over the long term through a focused portfolio of high quality JSE listed equity securities.

The fund is managed by Jean-Pierre du Plessis, a director of Stonehage Fleming Global Equity Management (South Africa). Jean-Pierre has almost 20 years experience in equity markets and joined the Group in 2011 to help establish the Group's onshore direct equity offering.

FUND COMMENTARY

After a weak start to the year in January and February, the local equity market eked out a marginal gain in March to see the JSE Capped SWIX decline -2.3% for the quarter. Of the major sectors only the JSE Industrial Index managed to deliver a positive return for the quarter with the JSE Financial, Industrial and Resource Indices returning -7.5%, 0.6% and -1.6% respectively.

Despite some moderation in the share price towards the end of the period, Richemont returned 12.5% for the quarter. The company reported 3rd quarter sales growth of 8% (at constant exchange rates) which was better than market expectations and allayed fears of a sharp decline in global luxury goods demand. Despite resilience in company fundamentals, bank holdings Firstrand (-13.3%) and Standard Bank (-11.0%) had weak quarters as generally weak domestic sentiment and activity levels weighed on share prices. Remgro's (-24.8%) interim results reported a 4.6% decline in Net Asset Value largely as a result of 46% decline in the value of Heineken Beverages.

On the domestic macroeconomic front, and on a positive note, average load shedding for the year-to-date is running approximately two stages below 2023 levels. The improvement is largely attributable to the continued growth in private sector generation. In addition, recent changes in senior management at Transnet has been welcomed by the private sector with a clear indication that the private sector will assume greater involvement in port and freight operations.

National elections are scheduled for 29 May and the uncertainty surrounding the outcome and permutations around potential coalitions has negatively impacted consumer and business confidence levels. The current base case forecast amongst political analysts is that ANC will fall below 50% of the vote (from 58% in 2019) and enter into a coalition with smaller parties to ensure a majority government. This is likely to be received in a neutral (to potentially positive) manner by business and market participants as a significant element of uncertainty is cleared.
