### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI World Index Total Return at low cost. Although the Fund is structured similarly to the MSCI World Index, it is not a tracker fund and can out / underperform the MSCI World Index by small amounts over time.

### INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the MSCI World Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI World Index or subsets thereof in a low cost and efficient manner.

### WHO SHOULD INVEST


Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI World Index and who are cost conscious.

### RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

## FUND COMMENTARY

The first month of 2026 delivered broadly solid returns for equity investors, with meaningful diversification across regions and sectors. While the extension of year-end risk-on sentiment was evident, precious metals performed strongly in January, with gold reaching new all-time highs, underscoring persistent demand for defensive assets alongside the broader risk-on backdrop. The MSCI World Index closed the month up 2.24%, supported by stronger economic data, continued corporate resilience and a clear widening of market participation beyond US mega-cap leadership. Despite lingering macro uncertainty and episodic volatility, investors’ focus remained firmly on improving earnings visibility and the prospect of more balanced global growth.

In the United States, equity gains were more modest but nonetheless positive. The S&P 500 Index returned 1.45% for the month, underpinned by firm activity data and healthy earnings momentum, even as investors reduced exposure to large-cap growth names in favour of regional and cyclically exposed stocks. Financials were among the top performers, supported by stabilising rate expectations and improving earnings visibility.

European markets outperformed many peers. The Euro Stoxx Index delivered a 4.04% return for the month, buoyed by resilience in cyclical sectors, encouraging economic data and positive earnings revisions. Continued moderation in inflation, alongside a backdrop of supportive monetary conditions, helped sustain risk appetite across the region.

Japan was a standout contributor to global performance, with the Nikkei 225 Index surging 7.22%, driven by domestic economic momentum, sustained foreign inflows and favourable currency dynamics.

Emerging market shares and commodities were among the strongest performers globally in January, reflecting investor confidence extending beyond traditional US-centric leadership. The MSCI Emerging Markets Index delivered a particularly strong 8.85% return for the month, materially outperforming more defensive corners of the market. Within emerging markets, China’s CSI 300 Index finished up 2.18%, supported by targeted policy measures and improving investor sentiment.

On the domestic front, sector rotation was evident throughout the month. The FTSE/JSE All Share Index climbed 3.72%, underpinned by robust performances across resource and industrial exposures. Basic materials led all major sectors with a 12.68% return, reflecting continued strength in commodity demand and pricing. Yield-sensitive assets also found renewed interest, with financials rising 2.97% and the listed property sector returning just under 1.00%. In contrast, technology was the lone major segment to give back ground, declining 9.82% for the month as investors reassessed valuations following a period of concentrated growth leadership.

Currency dynamics were notable. The rand strengthened by 2.50% against the US dollar over January, supported by firmer commodity prices, improved global risk appetite and elevated carry in emerging market linked assets.

The top contributors to the Fund’s performance for the month were Micron Technology Inc (45.36%), ASML Holding NV (31.93%) and Alphabet Inc (7.99%). Detractors included Microsoft Corp (-11.03%), Apple Inc (-4.55%) and Broadcom Inc (-4.28%).

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
