

Investment Objective

The portfolio will aim to deliver long term capital growth through equity centric investments in global markets.

Investment Policy

The aim of the Resolute Global Equity Prescient Fund of Funds is to provide investors with high capital growth through equity centric investments in global markets with the aim to generate returns in line with global equity markets, measured with reference to the MSCI ACWI, over rolling five-to-seven-year periods.

The portfolio will invest at least 80% of its assets outside of South Africa and a minimum of 80% in equity. The underlying portfolios may allocate capital across a variety of assets which includes but is not limited to equity securities, property securities, money market instruments, preference shares, bonds, other interest-bearing instruments and other listed and unlisted financial instruments as permitted by legislation from time to time.

Glossary Summary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request. Annualised performance is net of fees.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Sortino Ratio: Measures risk-adjusted return by focusing only on downside volatility — a higher figure means better returns for the downside risk taken.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

Fund Specific Risks

Default risk: The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuer's credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Developing Market (excluding SA) risk: Some of the countries invested in may have less developed legal, political, economic and/or other systems. These markets carry a higher risk of financial loss than those in countries generally regarded as being more developed.
