

FUND OBJECTIVE

The Fund aims to deliver medium to long-term capital growth over time. The Fund is differentiated in the ASISA South African – Multi-Asset – High Equity category by focusing primarily on investments with international or Rand-hedge revenue streams. Elevated returns are targeted by utilising its full offshore and equity allowances. The Fund complies with Regulation 28 of the Pension Funds Act.

INVESTOR SUITABILITY

The Fund is suitable for retail and institutional investors seeking maximum offshore exposure, within the bounds of Regulation 28. Therefore, it is appropriate for retirement savings and Tax-Free Savings Accounts. While volatility is expected to be less than an equity-only fund, investors must be willing to endure periods of short-term downturns. An investment horizon of 5+ years is recommended.

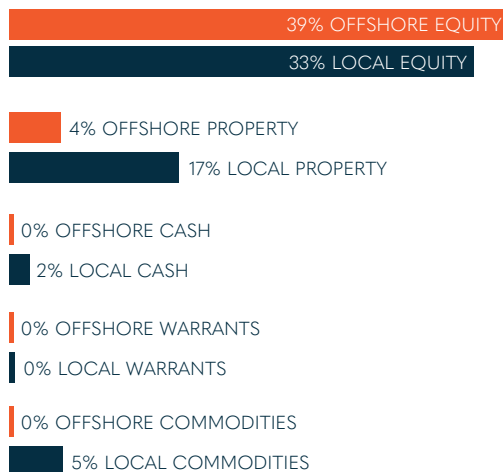

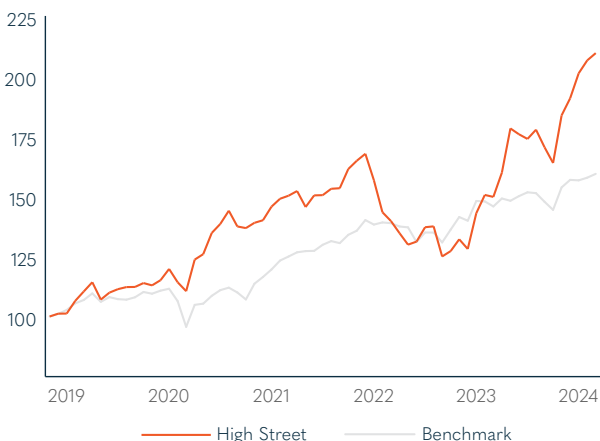

FUND COMMENTARY

For the month of March, the Fund returned 1.5%, outperforming the category peer average of 1.0%.

Global equities finished off the first quarter of 2024 strongly, with the S&P 500 posting a 3.2% return in USD in March, as the breadth of the current market rally improved with all 11 sectors gaining. The rally has been supported by robust US corporate earnings, which are expected to continue with EPS forecasted to grow 11% in 2024. The market was buoyed by US Fed Chair Jerome Powell expressing confidence in achieving a 'soft landing' for the economy and pointing to potential future interest rate cuts in his appearance before Congress. However, he emphasized the importance of awaiting more evidence before deciding on the timing of these cuts. Domestically, the JSE All Share Index returned 3.2%, while the Rand appreciated by 1.7% against the US Dollar.

The offshore component of the Fund displayed varied performance, with Nvidia emerging as the standout performer, delivering a return of 14.2% in USD. In March, Nvidia held its annual developer conference, during which CEO Jensen Huang introduced their latest flagship AI chip, the B200. It boasts a remarkable 30-fold increase in speed for certain tasks compared to its predecessor. Additionally, Huang introduced a new set of software tools aimed at simplifying the process for developers to sell AI models to companies leveraging Nvidia technology. Starbucks was the biggest detractor, returning -5.9% in USD. This was partially attributed to reports that a significant franchise operator, responsible for operating licensed Starbucks stores in the Middle East and North African regions, was laying off more than 2,000 employees. The decision comes as the business continues to grapple with ongoing consumer boycotts associated with the conflict in Gaza.

The local component also produced mixed performance. Glencore was the top performer, paring all the previous month's losses by returning 14.2%, supported by robust commodity prices. March saw a 2.9% increase in the Bloomberg Commodity Index, with Materials and Energy being the top performing sectors on the S&P 500. Richemont was the biggest detractor, returning -5.9%, attributed to lacklustre consumer data from China and sector-wide weakness, with Consumer Discretionary being the worst performing sector on the S&P.

Gold, from which the Fund gains exposure via the NewGold ETF, exhibited strong performance, with the ETF returning 6.7%. This surge was driven by expectations of falling real rates following Powell's testimony. Demand on the physical side also remained robust, supported by strong central bank purchasing and significant flows to the east.

The property component significantly bolstered the Fund's performance, with holdings yielding a weighted gain of 6.0%, compared to the 1.9% gain of the Developed Property Index. LEG Immobilien, demonstrated the strongest performance, returning 17% in EUR. LEG was upgraded to Barclays favoured German residential play, with the research house pointing to LEG offering the most attractive funds from operation yield and the company being more open to raising equity to fund investment in a depressed property market.

The quarter saw the following changes to the Fund composition:

Equity exposure dropped from 74% to 72%, while the property exposure was relatively unchanged. Commodity exposure, with investment solely via the NewGold ETF, increased from 3% to 5% in the quarter. Cash exposure remained unchanged at 2% of the Fund.

NAV: The net asset value represents the assets of a Fund less its liabilities.

WHY IS THIS FUND IN CATEGORY 4 ?

The Fund is rated as 4 due to exposure to shares and stocks, and the nature of its investments which include the risks previously listed. WHAT DO THESE NUMBERS MEAN?
