

QUARTERLY FUND COMMENTARY (AS OF Q2 2025)

The second quarter of 2025 was shaped by a complex interplay of domestic resilience and global recalibration.

Domestically, South Africa benefited from subdued inflation (headline CPI at 2.8% in May), a supportive monetary policy shift (repo rate cut to 7.25%), optimism around fiscal consolidation, and accelerating infrastructure investment with Operation Vulindlela in its second phase.

South African equities delivered a strong performance in Q2 2025, with the JSE All Share Index rising 10.2% for the quarter and 16.7% year-to-date. This was driven by gains in the resource and industrial sectors, supported by rising commodity prices, a weaker US dollar, and improving domestic fundamentals. Large-cap stocks led the rally, returning 21.2% year-to-date, while mid- and small-cap stocks lagged.

Gold, a key South African export, surged 24.4% in USD terms, improving South Africa's terms of trade and supporting a 3.5% appreciation in the rand. South African bonds also delivered a strong return of 5.9% for the quarter, outperforming cash (1.8%) and reflecting renewed investor confidence in the country's fiscal trajectory. The yield on the 10-year government bond declined to 10.0%, from 10.6% in Q1, supported by a more constructive global risk environment, growing optimism around a potential recalibration of the SARB's inflation target, and continued fiscal discipline. The government's primary budget surplus—estimated at 0.7% of GDP for FY2024/25—further reinforces the credibility of its fiscal consolidation path.

Globally, markets were shaped by a shift in US trade policy. While initial tariff shocks under President Trump unsettled investors, a move toward negotiation

helped ease uncertainty. The US dollar weakened sharply—down 10.7% year-to-date—prompting a reassessment of global asset allocations.

Global equity markets rebounded sharply over the quarter. The MSCIWorld Index rose 11.6%, while emerging markets gained 12.2%, led by Latin America and Asia. The US dollar weakened significantly, prompting a reassessment of global asset allocations. Despite fading tailwinds from fiscal stimulus and mega-cap tech dominance, US equities remained supported by structural strengths such as innovation and shareholder discipline. However, foreign investor flows into South Africa remained cautious, with net outflows in June, particularly from banks, food producers, and tech.

From a portfolio perspective, several individual positions contributed meaningfully to performance during the quarter. Offshore, our US positions still delivered robust returns. Our global EM exposure benefited from the broader rotation away from US assets. Notably, our global value exposure proved beneficial, with strong absolute and relative returns this years and over the past 12 months. Locally, passive equity exposure ensured the portfolio participated in the rally in SA resources.

While we have healthy exposure to US and global equities in the portfolios, we remain constructive on SA equities. Corporate balance sheets are strong, management teams are experienced in navigating uncertainty, and valuations remain undemanding. In this environment, our portfolio continues to follow a balanced and diversified approach.

GLOSSARY SUMMARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities. **Alpha:** Denoted the outperformance of the fund over the benchmark.

FUND SPECIFIC RISKS

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Interest Rate Risk: The value of fixed income investments (e.g., bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Max Gain: Largest increase in any single month
