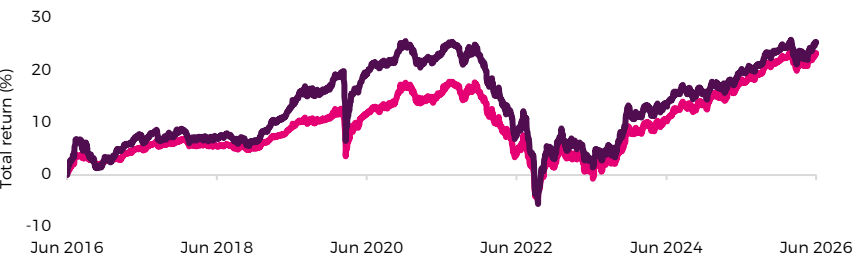
Investment Strategy

At least 80% of the fund is invested either directly or indirectly in a diversified portfolio of investment grade rated corporate bonds issued by companies. This may include non-investment grade (lower quality) bonds, convertible bonds (bonds that can convert into company shares), Contingent Convertible Bonds and other investments with similar characteristics to bonds. The fund managers assess the broad global economic environment, focusing on areas such as economic growth, inflation expectations and the outlook for interest rates to determine the attractiveness of the asset classes and of the individual investments within those asset classes. The portfolio is expected to have between 80 and 170 individual issuers of bonds and is likely to have exposure to a broad range of sectors such as financial and utility companies. 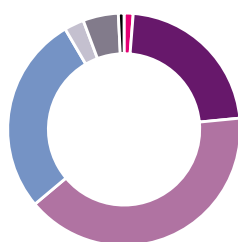

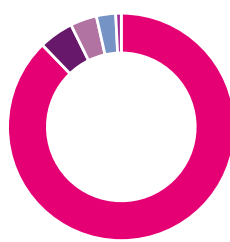

Credit rating (%)



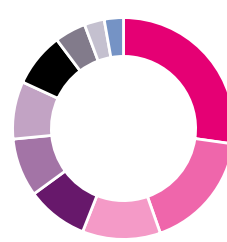

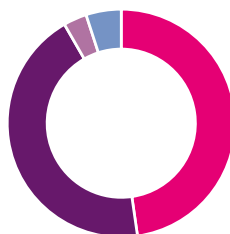

Distribution Yield 5.09%

The distribution yield reflects the expected income distribution over the next twelve months as a percentage of the fund price as at the date shown. Underlying Yield 4.88%

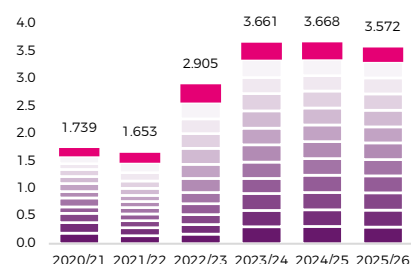

Other information

This fund is priced on a swing pricing basis. A swing pricing is where the price can swing to either a bid or an offer basis depending on the investment and redemption activity in the fund. This means the investor selling or buying fund

shares bears the associated [dis] investment costs and protects the continuing holders in the fund.

General risks

Specific fund risks

Fixed income

Fixed income investments, such as bonds, can be higher risk or lower risk depending on the financial strength of the issuer of the bond, where the bond ranks in the issuer's structure or the length of time until the bond matures. It is possible that the income due or the repayment value will not be met. They can be particularly affected by changes in central bank interest rates and by inflation.

Derivatives

Derivatives may be used within funds for different reasons, usually to reduce risk, which can be called

"hedging". This can limit gains in certain circumstances as well. Derivatives can also be used to generate income or to increase the risk being taken, which can have positive or negative outcomes. The derivatives used can be options or futures which are types of contracts that are dealt on an exchange or negotiated with a third party. More complex derivatives may also be used. Derivatives can also introduce leverage to a fund, which is similar to borrowing money to invest.

Other investment risks

Funds may have holdings in investments such as commodities (raw materials), infrastructure and property as well as other areas such as specialist lending and renewable energy. These investments will be indirect, which means accessing these assets by
