

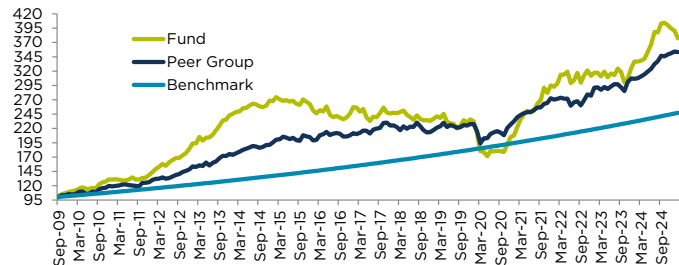
## FUND OBJECTIVE & STRATEGY

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

## MONTHLY COMMENTARY

February was a brutal month, with only 6 of the fund's 28 holdings ending in the green. The shift in sentiment sparked by some aggressive actions and comments from President Trump sent the US small-cap index down 6% and even the tech-heavy Nasdaq was not spared. The JSE small- and mid-cap indices were -2.3% and -4.2% respectively.

The gold stock, Pan African Resources, fell 15% in the month after delivering difficult interim results. With the gold hedge required to build the latest tailings facility finally delivered, the earnings will increase by over R90m per month at the current gold price.

On a positive note, the Chinese government is making a concerted effort to push the Chinese market higher, creating a wealth effect for Chinese citizens after a rout in the Chinese housing market impacted consumer sentiment considerably. The fund holds the China ETF, which was up 10% for the month.

Grindrod was up almost 8% in Feb off a low base after delivering a decent result, from which the company expects to grow earnings based on R8bn of growth opportunities. We have highlighted rail reform many times and Grindrod have locomotives and wagons in South Africa ready to start operations when the slots are granted in the next two months. In addition, they have negotiated the Richards Bay container terminal which will be the first private container terminal in South Africa and expect to complete the Matola expansion within the next year as this facility is running ahead of design capacity.

We hope for less turmoil from the White House which would shift sentiment but acknowledge that that is not Trump's style. We are currently witnessing a shift from growth into value and from the US into Europe and China, which should benefit the JSE.

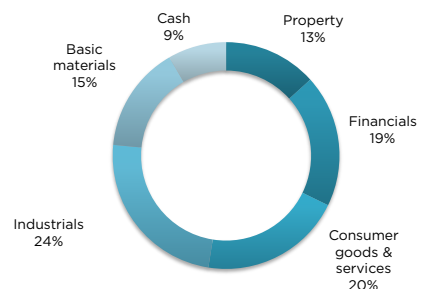
