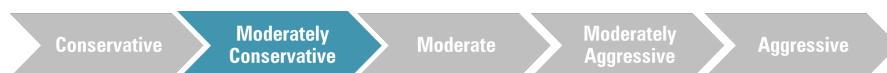


## Investment Objective & Strategy

The **WealthStrat Cautious Prescient Fund of Funds** will aim to deliver high levels of income and capital stability. The manager shall have limited flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The Fund will employ asset and limited geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **WealthStrat Cautious Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The equity allocation will be managed at a maximum effective exposure, including offshore equity, up to 40%. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in South African markets but is however permitted to include investments in offshore jurisdictions subject to the investment conditions determined by legislation from time to time.

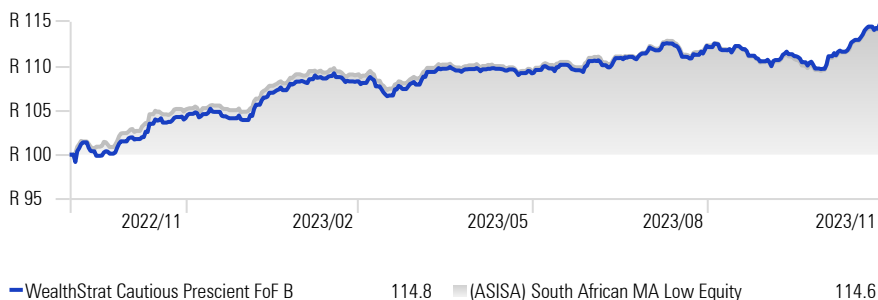

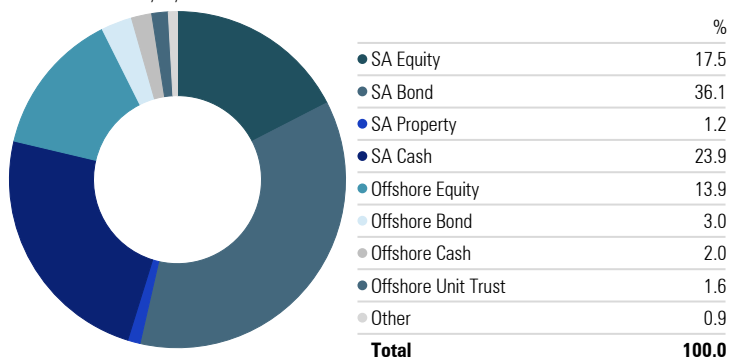

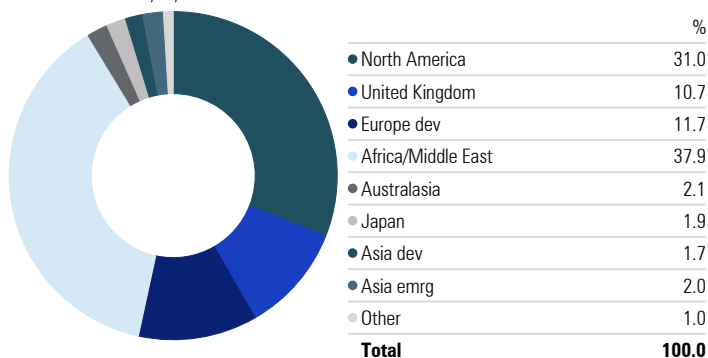

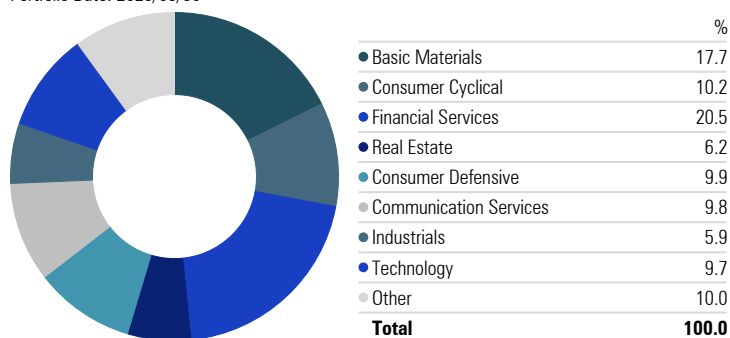
## Equity Regional Exposure

## Quarterly Fund Commentary

Conservative investors generated mixed returns in the third quarter of 2023, in the face of a particularly weak global and local environment. Positive returns from short duration asset classes acted as a tailwind to the performance of the Portfolio over the quarter. However, the rand's strength was a headwind to the performance of the Portfolio over the quarter.

The WealthStrat Cautious Prescient Fund of Funds returned 0.0% for the quarter and has generated a return of +10.6% over the past year.

The Portfolio remains diversified in terms of its exposure to various asset classes, and we remain confident in its ability to deliver inflation-beating returns over the long term, independent of the market environment.

### Asset Allocation

Local bonds make up the bulk of the asset allocation within the Portfolio. This includes allocations to corporate, government and inflation-linked bonds. Short dated nominal bonds held up well over the quarter and were one of the few asset classes to produce a positive performance. On the other hand, longer-dated instruments returned a negative performance during the quarter as yields across the curve rose, leading to lower bond prices. The negative move was largely on the back of the hawkish tone from the central bank governor coupled with concerns surrounding the South African fiscal outlook, which led to a selloff in South African bonds. All eyes will be on the upcoming Medium-Term Budget Policy Statement (MTBPS) scheduled for the 1st of November, which will provide an update on the state of government finances. Local cash allocations managed to deliver positive returns this quarter, ahead of most other asset classes given the higher yield due to recent interest rate hikes. Local equities ended the quarter lower, largely driven by the industrial (-6.2%) and the resources (-4.4%) sectors, which both ended the quarter in negative territory. The negative sentiment surrounding China impacted certain dual-listed industrial shares such as Richemont (-25.4%), Naspers (-11.0%) and Prosus (-11.7%), which have significant exposure to the Chinese consumer. Resources counters had a tough quarter, as platinum miners took a leg lower. Anglo American Platinum Ltd (-15.6%), Impala Platinum Holdings Ltd (-19.8%) and Northam Platinum Holdings Ltd (-3.7%) all recorded declines over the quarter. The financials (+2.2%) sector produced resilient returns this quarter, as the sector ended in positive territory, led higher by index heavyweights Capitec (+9.5%) and ABSA (+8.2%). Global equities had a tough quarter, with most equity markets ending in negative territory. Given the risk-off environment, value stocks held up better than growth stocks this quarter, however, they still ended in negative territory. Most global equity markets produced weak hard currency performance this quarter, with the rand providing a further headwind to performance. Offshore bond and cash allocations detracted from performance this quarter, as the firmer rand acted as a headwind to the performance of offshore allocations. A small allocation to local listed property detracted from performance this quarter, as the property sector ended marginally lower, however, the sector outperformed similar risk assets. The fund's asset allocation is broadly similar to the previous quarter.

### Fund Selection

The contribution from fund selection was mostly mixed for the quarter.

Nedgroup Investments Core Bond struggled to generate meaningful performance over the quarter; weighed down by weak performance from medium and long dated SA government bonds. This was largely due to hawkish comments from the South African Reserve Bank as well as concerns surrounding the South African fiscal outlook. Furthermore, yields moved higher across the curve during the quarter, which impacted prices negatively.

PSG Equity delivered strong top quartile performance this quarter; producing a positive return during a period in which the local equity market was broadly negative. The performance was driven predominantly by the Fund's industrial and foreign exposure. Within their local exposure, the Fund's holdings in AECI (+25.9%), Sun International (+26.3%) and Thungela Resources (+24.1%) were the main contributors to performance. Within the Fund's Foreign component, Noble Corp (+23.0%) and Babcock International Group (+40.1%) were the top performers, while Pepco Group (-47.4%) and Prudential Plc (-21.6%) were the main detractors.

Ninety One Global Franchise FF's performance was in line with its benchmark over the quarter but slightly behind its peers. The Fund's investment process tends to shy away from the more cyclical sectors like energy and traditional financial companies, which held up better over the third quarter. Furthermore, a firmer rand acted as a headwind to the performance of offshore allocations. Furthermore, firmer rand acted as a headwind to the performance of global assets in the third quarter.

There were no changes made to the underlying funds in the Portfolio in the third quarter.

## Summary

We are pleased that the Portfolio managed to generate a resilient return over the third quarter in the face of a particularly weak global and local environment. The Portfolio continues to be allocated to a diverse range of attractively priced local and global asset classes and we are confident that it will be able to deliver on its investment objective over the long term. The fund has adhered to its policy objective.

## Glossary

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month

## Fund Specific Risks
