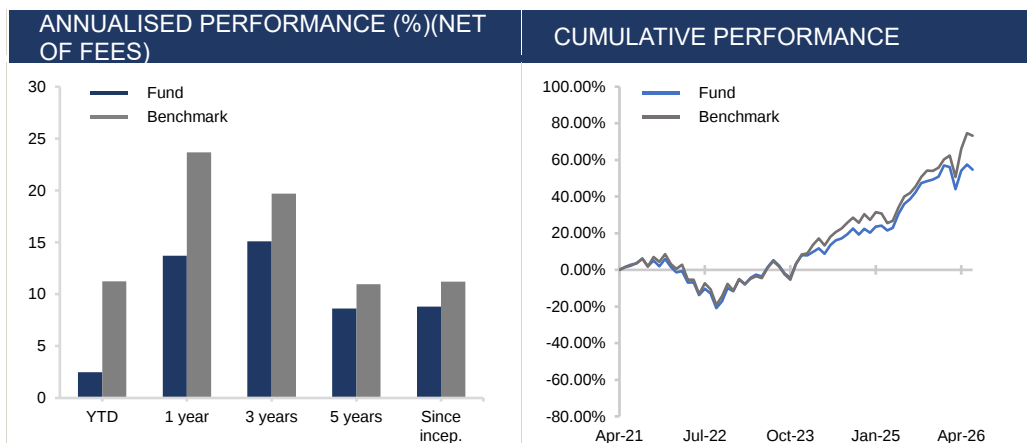
PORTFOLIO INVESTMENT STRATEGY

The Global Equity UCITS Portfolio seeks to deliver long-term capital growth that is superior to its benchmark, the MSCI All Country World Index ("MSCI ACWI"). The Fund invests with a Quality style and the portfolio managers aim to select stocks that offer the highest intrinsic valuation upside relative to their quality as measured through our proprietary Benguela Quality Score. The portfolio was transitioned to the Ireland UCITS structure during October 2018.

RISK INDICATOR DEFINITION

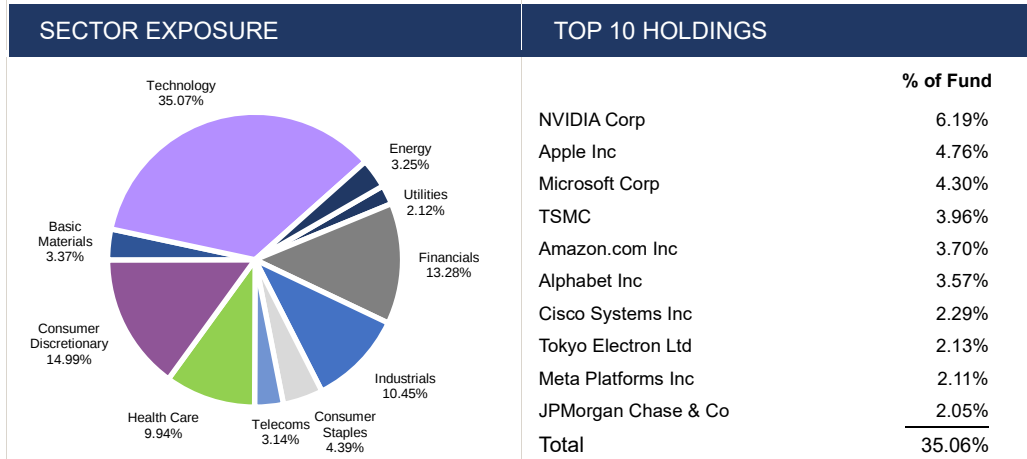

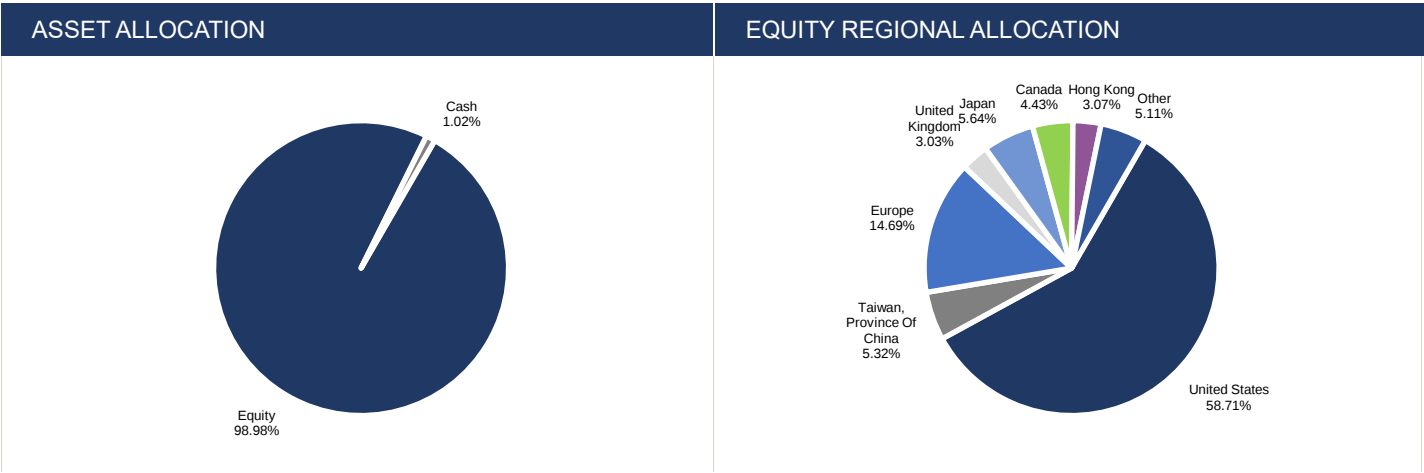

FUND COMMENTARY

The Portfolio has followed and complied with its policy objective.

In the second quarter of 2026, the Benguela Global Equity UCITS Fund (BGEUF) delivered a gross USD return of 7.5%, trailing the 14.9% total return of the MSCI ACWI benchmark by 744 basis points. Over the trailing twelve months to June 2026, the Fund returned 14.6% in gross USD terms, 903bps behind the benchmark's 23.7%. The quarter was defined by an exceptionally narrow, momentum-driven market rally as investors looked through the Middle Eastern conflict and refocused on the artificial intelligence investment cycle, an environment that proved challenging for the Fund's quality philosophy and valuation-disciplined approach.

Market leadership was concentrated almost entirely in technology and the semiconductor complex. The technology-heavy indices led – the Nasdaq Composite rose 21.6%, Japan's Nikkei 225 gained 34.5%, and the MSCI Emerging Markets Index advanced 24.2%, driven by the semiconductor-heavy South Korean and Taiwanese exchanges. Information Technology was the only sector in the index to outperform the benchmark, returning 38.7%, with gains led by lower-quality, highly cyclical semiconductor businesses as supply bottlenecks created an unprecedented price cycle. Energy was the weakest sector, down 13.7%, as Brent crude fell from approximately \$125 to approximately \$70 a barrel following the signing of a memorandum of understanding between the United States and Iran. The US Treasury curve flattened as the market repriced the risk of Federal Reserve rate hikes under new, more hawkish Chair Kevin Warsh.

The Fund's underperformance was driven primarily by selection, concentrated within Information Technology. Not being invested in the highly cyclical, lower-quality semiconductor names – including the memory chip oligopoly and Intel – weighed on performance, while our higher-quality overweight in Microsoft and Nvidia underperformed. We believe the memory rally has become speculative and momentum-driven, and while the price cycle may extend for some time, current share prices cannot be justified by any forecast incorporating a degree of normalisation. Our underweight positions in Micron, SK Hynix and Advanced Micro Devices were the leading detractors, alongside Zoetis and Lockheed Martin, both now under review. On the positive side, our preferred, higher-quality exposures to the semiconductor supply chain – Tokyo Electron, TSMC, ASML – together with Cisco Systems and Siemens, were the leading contributors.

Portfolio management outlook

There is now greater visibility to an end to the Middle Eastern conflict, though risks remain, particularly around energy prices, and inflation and the interest rate outlook have increased as risks for markets. The momentum rally has moved far and fast, leaving a high likelihood of a correction in the leading names, and with greater visibility to a post-conflict environment we expect a broadening out of market performance. We have focused our research effort on the Fund's Information Technology underweight and are reducing it, seeking to increase exposure to the secular AI trend without chasing momentum or compromising our valuation discipline. The quality characteristics of the Fund's underlying holdings, anchored in companies with fortress balance sheets and robust business models through cycles, provide the primary layer of defence in a downside scenario while still allowing participation in a more constructive market environment.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.
