

COMMENTARY

The CAEP Venture Fund experienced a more volatile quarter, reflective of its higher equity and offshore exposure. Despite short-term market fluctuations, the fund continues to pursue its CPI +7% return target over longer time horizons.

Performance was supported by select technology and global equity holdings, though emerging market exposure presented headwinds. We remain committed to growth-focused assets with a long-term view, accepting higher short-term volatility in pursuit of meaningful inflation-beating returns for investors with higher risk tolerance.

GLOSSARY

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Average Credit quality: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.
