The Fund invests in cash, money market and high-quality capital market (nominal or real) instruments including structured notes. Fund performance can be generated from taking interest rate or duration views, yield enhancement via credit instruments and also via the use of derivatives.

WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to investors with a short-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% - 3% above inflation before tax over the long term.





FUND COMMENTARY

December saw a continuation of the positive momentum in the South African (SA) Fixed Income market with another strong performance month, ending the year on the front foot. The US economy defied the fears of many market participants in 2023 and made substantial progress towards a "soft landing". This, together with pricing pressures subsiding, has resulted in markets continuing to price in the end of the tightening cycle. The US market is pricing in almost a 2% reduction in rates by the Federal Reserve by the end of the forecast period. In South Africa, the market has moved to price in something similar, with the first rate cut priced for the end of Q1 2024. However, the SA market anticipates a 1% reduction.

The Fund had a good performance month during December. The move lower in rates benefitted the duration position. The positive yielding assets also added to the return for the month. The 2023 calendar year return saw us achieve our return target within our risk target.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
