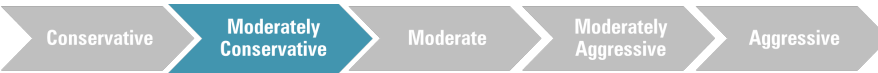


Investment Objective & Strategy

The **WealthStrat Cautious Prescient Fund of Funds** will aim to deliver high levels of income and capital stability. The manager shall have limited flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The Fund will employ asset and limited geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **WealthStrat Cautious Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The equity allocation will be managed at a maximum effective exposure, including offshore equity, up to 40%. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in South African markets but is however permitted to include investments in offshore jurisdictions subject to the investment conditions determined by legislation from time to time.

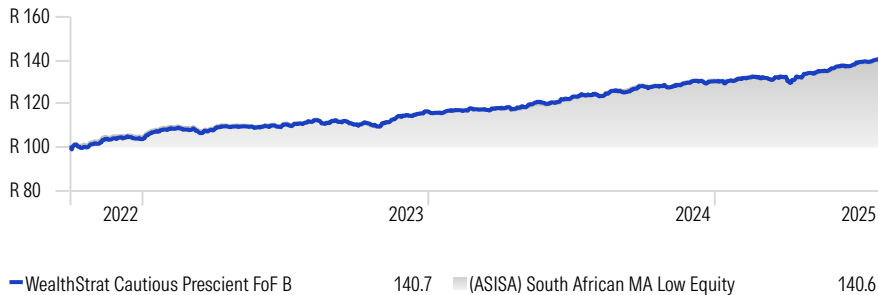

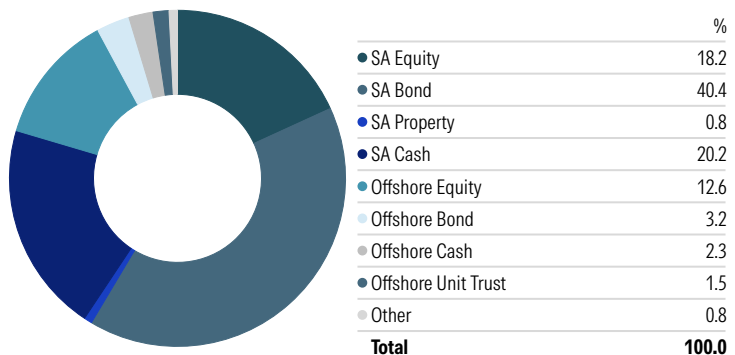

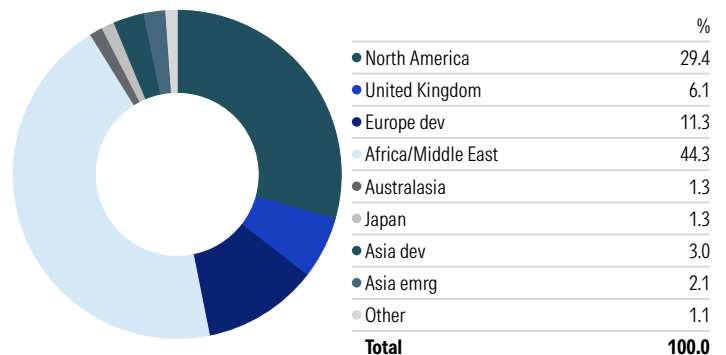

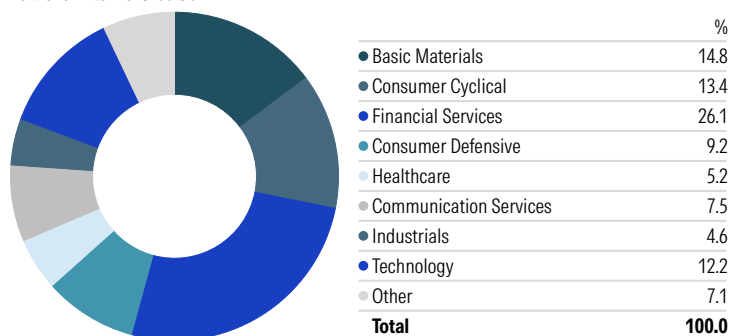
Equity Regional Exposure

Quarterly Fund Commentary

Conservative investors generated strong returns in the second quarter of 2025. Local bonds delivered strong returns over the quarter, as a broad-based decline in yields drove bond prices higher across the curve. The higher starting yield on cash and short-dated nominal cash instruments continued to deliver a stable return profile, benefiting income-based and low equity portfolios. However, the appreciation of the rand during the quarter provided a headwind for offshore equities, which detracted from the overall performance.

The WealthStrat Cautious Prescient Fund of Funds returned +4.8% for the quarter and has generated a return of +13.2% over the past year.

The portfolio remains diversified in terms of its exposure to various asset classes, and we remain confident in its ability to deliver inflation-beating returns over the long term, independent of the market environment.

Asset Allocation

Local bonds constitute the majority of the portfolio's asset allocation, including investments in corporate, government and inflation-linked bonds. South African bonds delivered strong returns over the quarter, as a broad-based decline in yields drove bond prices higher across the curve. Longer-dated maturities saw particularly pronounced gains, as the yield on 10-year government bonds declined significantly over the period. Markets were also attentive to the potential introduction of a lower inflation target by the South African Reserve Bank (SARB), which could have long-term implications for the country's monetary policy framework and potentially anchor future rate expectations at lower levels. Local cash allocations also provided steady positive returns over the period. Local equity markets posted strong returns over the quarter, with broad-based strength displayed across local equity sectors. The Industrials sector (+11.8%) posted strong returns over the quarter, buoyed by strong performances from index heavyweights Naspers and Prosus. However, the retail sector remains a drag on the overall market with stocks such as Mr Price, Pepkor and Woolworths underperforming the broader market. Financials (+8.5%) and Resources (+9.2%) posted strong performance over the quarter, with pronounced returns from underlying gold and platinum mining stocks. Property (+9.1%) posted some strong returns of the quarter, erasing some of its weaker performance earlier this year. Global equities generally produced strong returns over the second quarter. While US equities rebounded from their early-April selloff, international developed and emerging markets remain ahead year-to-date, with the MSCI EAFE Index (Europe, Australasia and the Far East) outperforming the Morningstar US Market Index by over 13%. Beyond short-term volatility, market leadership is shifting in more structural ways. The "Magnificent Seven" are no longer moving in lockstep; four out of the seven have underperformed the broader market, with Tesla (-21.3%) and Apple (-17.9%) in or near bear market territory. In contrast, industrials, utilities and financials have emerged as leading US sectors, marking a distinct rotation away from tech dominance. Emerging markets have also surged, rising more than 15% through June. In terms of investment styles, growth stocks outperformed value stocks over the quarter, while small-cap stocks continued to lag the broader market. Offshore bond exposures continued to contribute meaningfully over the quarter, with the broad US bond market (measured by the Bloomberg US Aggregate Bond Index) up nearly 4% for the year. At current yield levels, bonds are once again contributing meaningfully to total return, offering not only downside protection but also real, consistent income, reinforcing their strategic role in a well-balanced portfolio. Furthermore, offshore cash allocations made a positive contribution to overall portfolio performance. The stronger rand acted as a headwind to the performance of offshore allocations. The fund's asset allocation is broadly similar to the previous quarter.

Fund Selection

The contribution from fund selection was mostly positive for the quarter.

Nedgroup Investments Core Bond delivered strong performance over the quarter, supported by the positive returns from medium and long dated SA government bonds. The local nominal yield curve shifted lower, which led to meaningfully lower yields (higher prices) during the quarter. A key development during the quarter was the announcement by the South African Reserve Bank (SARB) that they are considering lowering the local inflation target by changing it from a range of 3-6% (midpoint of 4.5%) to a point target of 3%. This, along with a supportive global environment and lower US treasury yields, created a strong tailwind for the local bond market.

Ninety One Diversified Income delivered decent returns over the quarter, outperforming the fund's STEFI Composite benchmark, but lagging peers whose positioning was generally less conservative than that of the fund. Ninety One Diversified Income benefited from the significant rally that we saw in the SA bond market over the quarter. Duration positioning has been on the cautious side, but Ninety One have added back some duration during the quarter, particularly in the longer dated part of the yield curve. From a currency perspective, Ninety One remain constructive on the Rand, which continued to strengthen over the quarter, but they are mindful of the role foreign exchange exposure can play in the portfolio as a release valve for risk when sentiment sours. Against this backdrop, they currently favour the Euro over the US dollar within their currency exposure.

Aylett Equity Prescient delivered positive performance in the second quarter, outperforming both its FTSE/JSE All Share Index benchmark and the ASISA peer group average over this period. Outperformance over the quarter was driven predominantly by stock selection in both the locally listed and offshore components of the portfolio. On the local side, the main contributors to performance over the quarter were the holdings in We Buy Cars (+42.9%) and Reinet Investments (+29.4%). On the offshore side, holdings in St. James's Place (+25.6%) and Aylett Global Equity Fund (+11.3%) were the main contributors to performance.

During the second quarter, the WealthStrat Cautious Prescient FoF made a portfolio change by replacing Coronation Strategic Income with Granate BCI Multi-Income.

Summary

We are pleased that the portfolio delivered a decent return over the second quarter, despite a relatively volatile global market environment. The portfolio continues to be allocated to a diverse range of attractively priced local and global asset classes. We are confident that it will be able to deliver on its investment objective over the long term. The fund has adhered to its policy objective.

Glossary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

Fund Specific Risks
