Investment Objective & Strategy

The **Wealthstrat Worldwide Flexible Prescient Fund of Funds** will aim to deliver a high level of capital growth. The manager shall have maximum flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The fund will employ asset and geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **Wealthstrat Worldwide Flexible Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in offshore jurisdictions subject to the investment conditions determined by legislation however investments in South African Markets may be included from time to time.








Equity Regional Exposure

Quarterly Fund Commentary

Aggressive investors generated negative returns in the third quarter of 2023, as most risk assets recorded poor performance. Weak returns from global and local asset classes acted as a headwind to the performance of the Portfolio over the quarter. The firm rand provided a further headwind to the performance of the Portfolio over the quarter.

The WealthStrat Worldwide Flexible Prescient Fund of Funds returned -2.0% for the quarter and has generated a return of +18.3% over the past year.

The Portfolio retains a strong bias to global and local equities, which we expect to deliver significant inflation-beating returns in the long term.

Asset Allocation

Offshore equities make up the largest allocation in the Portfolio. Global equities had a tough quarter, with most equity markets ending in negative territory. Given the risk-off environment, value stocks held up better than growth stocks this quarter, however, they still ended in negative territory. Most global equity markets produced weak hard currency performance this quarter, with the rand providing a further headwind to performance. Local equities make up the next largest allocation in the Portfolio. Local equities ended the quarter lower, largely driven by the industrial (-6.2%) and the resources (-4.4%) sectors, which both ended the quarter in negative territory. The negative sentiment surrounding China impacted certain dual-listed industrial shares such as Richemont (-25.4%), Naspers (-11.0%) and Prosus (-11.7%), which have significant exposure to the Chinese consumer. Resources counters had a tough quarter, as Platinum miners took a leg lower. Anglo American Platinum Ltd (-15.6%), Impala Platinum Holdings Ltd (-19.8%) and Northam Platinum Holdings Ltd (-3.7%) all recorded declines over the quarter. The financials (+2.2%) sector produced resilient returns this quarter, as the sector ended in positive territory, led higher by index heavyweights Capitec (+9.5%) and ABSA (+8.2%). Local cash allocations managed to deliver positive returns this quarter, ahead of most other asset classes given the higher yield due to recent interest rate hikes. Offshore bond and cash allocations detracted from performance this quarter, as the firm rand acted as a headwind to the performance of offshore allocations. A small allocation to local listed property detracted from performance this quarter, as the property sector ended marginally lower, however, the sector outperformed similar risk assets. The fund's asset allocation is broadly similar to the previous quarter.

Fund Selection

The contribution from fund selection was mostly negative for the quarter.

BCI Fundsmith Equity FF delivered poor performance over the quarter. The Fund's underperformance was driven by its exposure to consumer cyclicals such as LVMH and Amadeus and consumer staples such as Estee Lauder and L'Oreal. Furthermore, due to the investment process, the Fund does not have any exposure to energy, which was the best performing sector over the quarter.

Nedgroup Investments Core Global FF had a difficult quarter, despite performing largely in line with its peer group. The Fund delivered weak performance, as all the underlying global asset classes delivered disappointing performance over the quarter. Global equities and global bonds struggled in the third quarter, as hawkish comments from the major global central banks led to risk-off sentiment in global markets. The firmer rand also acted as a headwind to the performance of global assets in the third quarter.

Ninety One Global Franchise FF's performance was in line with its benchmark over the quarter but slightly behind its peers. The Fund's investment process tends to shy away from the more cyclical sectors like energy and traditional financial companies, which held up better over the third quarter. Furthermore, the firmer rand also acted as a headwind to the performance of global assets in the third quarter.

There were no changes made to the underlying funds in the Portfolio in the second quarter.

Summary

While we are disappointed with the negative absolute performance, we are pleased the Portfolio held up well given the weak global and local market returns. We remain comfortable with the positioning of the Portfolio, both from an asset allocation and a manager selection perspective. The Portfolio continues to have a large allocation to global and local equities, which we expect to deliver significant inflation-beating returns over the long term. The fund has adhered to its policy objective.

Glossary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

Fund Specific Risks

Default risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
