INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return CPI + 3% per annum through a full interest rate cycle while providing stability by aiming never to lose capital over any rolling 3 month period.

INVESTMENT PROCESS

This Fund invests in local money market, bonds, inflation-linked bonds, preference shares and derivatives to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes and also via the use of derivatives.


WHO SHOULD INVEST

Investors seeking stable real returns and aiming to maximise income via exposure to primarily the South African Money and Bond markets. This Fund is suitable to investors with a short- to medium-term investment horizon and is Regulation 28 compliant.


RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. FUND COMMENTARY

South African fixed-income markets started 2026 on a stable footing, supported by a benign inflation backdrop and the South African Reserve Bank's continued commitment to a cautious and data-dependent policy approach. Following the 25-basis point cut delivered late in 2025, the South African Reserve Bank kept the repo rate unchanged at 6.75% in January, reiterating that inflation remains well anchored within the 3% ± 1pp target band and broadly aligned with the midpoint over the medium term. The Committee highlighted subdued domestic demand conditions and contained inflation expectations as key factors underpinning its current policy stance.

Local bond markets were stronger over the month, with carry continuing to drive returns across the curve. Longer-dated yields were range-bound as investors balanced South Africa's attractive real yield offering against ongoing fiscal and global uncertainty. The rand traded in a relatively narrow range, supported by improving global risk sentiment and lower volatility in developed-market rates.

Globally, fixed-income markets were characterised by growing confidence that major central banks are approaching the later stages of the tightening cycle. In the US, softer inflation prints and signs of cooling momentum in the labour market reinforced expectations for gradual policy easing later in the year. This supported demand for risk assets and helped keep credit spreads well contained, despite valuations remaining tight.

Against this backdrop, the Fund maintained a disciplined and balanced positioning. We continued to favour floating-rate instruments and shorter- to medium-dated exposures, where attractive carry and limited duration risk support capital stability. With credit spreads compressed, portfolio construction remains focused on high-quality issuers and maintaining liquidity. The Fund is well positioned to continue delivering stable income while retaining flexibility to selectively add duration or credit risk should valuation opportunities emerge.

The Fund's forward yield remains attractive at 8.39%. The Fund has an interest rate duration of 0.53 years and a total duration (including ILBs) of 0.62 years. The current risk profile aligns with the Fund's risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Fund delivered a positive performance in January. Key contributors were the higher yielding assets in the portfolio and our preferred duration bonds, the R2032 and the R2037. There were no detractors during the month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
