Fund Objective

The fund will, apart from assets in liquid form, consist solely of participatory interest in the approved, Sigma Select Global Leaders Fund under the Prescient Global Funds ICAV, an open ended umbrella fund with segregated liability between funds, domiciled in Ireland.

The investment objective of the underlying fund is to outperform the Benchmark, as measured by the MSCI ACWI, over the long term. The underlying fund will seek to achieve its objective primarily through investing of up to 100% of its net assets in global equities which are listed or traded on Recognised Exchanges, or subject to the investment restrictions set out in the supplement.

Fund Strategy

The Fund capital is allocated to a carefully considered blend of independently managed global and specialist equity strategies.

The Fund is constructed by optimally blending the various manager styles and strategies to achieve the return target over the long-term.

A rigorous investment process underpins the identification and selection of managers according to their key strengths and specialisation.

These managers include the best active stock-pickers that the fund manager has encountered globally and they all have long term track-records of successfully generating superior returns for their investors.

Each manager is constantly assessed relative to their appropriate benchmarks and must consistently comply with the fund manager's stringent due diligence criteria.

The Fund exposure is constantly monitored and reviewed, and may be adjusted from time to time, having regard to the prevailing market conditions







Illustration showing growth of R1,000 invested at date of inception 1

Quarterly Commentary - Q2 2025

Global equity markets staged a remarkable recovery during the second quarter of 2025, rebounding sharply from an early sell-off triggered by U.S. tariff announcements. The MSCI All Country World Index delivered a robust return of +11.6% in US\$ terms over the quarter, though this headline figure masked extraordinary intra-quarter turbulence that tested both investor resolve and market resilience.

The substantial weakening of the US dollar, as evidenced by the US\$ Trade-Weighted Index's (DXY) -7.1% decline over the quarter, set the tone for global asset class performance. This pronounced move in the greenback created a powerful tailwind for non-U.S. assets, materially lifting their returns when translated into US dollars.

The Sigma Select Global Leaders Fund, which maintains an underweight positioning to the U.S. equity markets relative to the MSCI ACWI benchmark, delivered a strong +13.0% return in US\$, outperforming the global benchmark. Year-to-date, the Fund has generated a +14.2% return, outpacing the MSCI ACWI's +10.3% performance, in US\$.

Strong quarterly performance from the Egerton Capital Equity Fund (+15.4%), Contrarius Global Equity Fund (+19.3%), and Orbis Global Equity Fund (+18.9%) contributed to the Fund's outperformance, offsetting the more modest gains from the Veritas Izoard Fund (+6.4%) and Lindsell Train Global Equity Fund (+9.0%).

Looking ahead, the second half of 2025 presents a particularly complex investment environment characterised by elevated valuation metrics, policy uncertainty, and monetary policy fragmentation across developed economies. We expect volatility to persist and have therefore retained a disciplined, regionally diversified portfolio, maintaining a strategic under-weight to US large-capitalisation technology where valuation risks remain most acute. We believe this approach positions the Fund favourably to exploit valuation dislocations and deliver superior risk-adjusted returns across the next market cycle.



Risk and Reward Profile of the Fund

Fund Specific Risks

In addition to the risk captured by the indicator above, the overall Fund value may be considerably affected by:

- Default risk: The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Glossary Summary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest and Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

 $\ensuremath{\text{NAV:}}$ The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio: The Sharpe Ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

%Positive Month: The percentage of months since inception where the fund has delivered positive return.

Volatility: Volatility is a statistical measure of the dispersion of returns for a given security or market index.

Feeder Fund: A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.
