INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI World Index Total Return at low cost. Although the Fund is structured similarly to the MSCI World Index, it is not a tracker fund and can out / underperform the MSCI World Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment process which firstly endeavours to follow the composition of the MSCI World Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI World Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI World Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

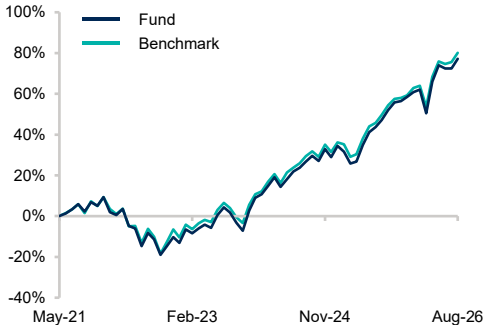
RISK INDICATOR

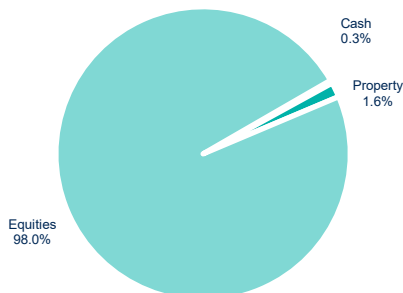

FUND COMMENTARY

Global equity markets recovered in August, with the MSCI World Index gaining 2.58% as the AI investment cycle reasserted itself and softer inflation data gave investors room to breathe. Where July had been defined by rotation away from technology, August ran the argument the other way: strong second-quarter earnings from the largest semiconductor and platform names, alongside evidence that the inflation scare was easing, drew capital back into the trade that had driven markets through much of the year. European equities advanced 1.77%, with the region's more balanced sector composition allowing it to participate in the recovery without the same degree of swing seen in more technology-concentrated markets. Japan's Nikkei 225 added 2.83%, recovering a portion of July's sharp decline as semiconductor names stabilised.

In the United States, the S&P 500 rose 2.72% and touched a new all-time high during the month. The driver was a familiar one: extraordinary earnings growth from AI-related names, with the largest chip and platform companies reporting results that offered evidence that the capital being deployed into AI infrastructure is beginning to generate returns. Softer-than-expected consumer price data reinforced the constructive backdrop. The Federal Reserve held rates steady, and the Jackson Hole conference at month end provided policymakers an opportunity to signal continued patience.

Emerging markets outperformed, with the MSCI EM Index gaining 3.37%, recovering meaningfully from July's decline of 3.07%. The reversal was driven in large part by a rebound in North Asian technology and semiconductor names, which had borne the brunt of July's sell-off. The CSI 300 added 1.30% as Chinese equities stabilised.

Overall, August was the mirror of July: the AI trade returned, inflation fears retreated and capital flowed back into the assets that July's rotation had pressed lower. Locally, the JSE's strong month owed almost everything to a commodities surge that few global peers could match. The month was a reminder that headline market performance can conceal significant dispersion beneath the surface, with technology, commodities and property each responding very differently to the same broader macro environment.

The top contributors to the Fund's performance for the month were NVIDIA Corp (9.98%), Microsoft Corp (9.16%) and Palantir Technologies Inc (51.45%). Detractors included Amazon.com Inc (-4.35%), Alphabet Inc A (-4.71%) and Alphabet Inc C (-5.96%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

This yield is subject to change as market rates and underlying investments change.
