The Fund will aim to deliver a high-income stream over the target period and to then wind-up or be re-purposed at the end of the target period.

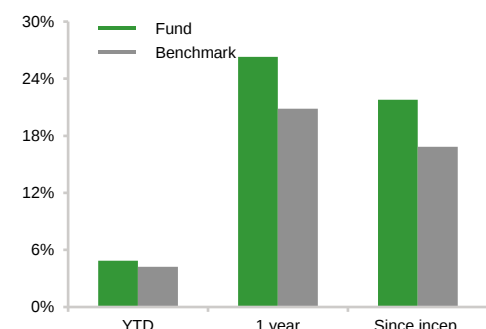
INVESTMENT POLICY

RISK INDICATOR

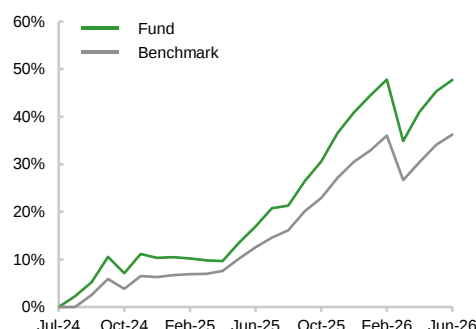


ANNUALIZED PERFORMANCE (%)

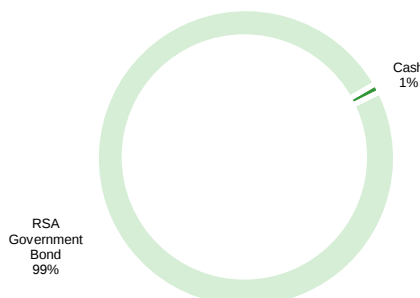

FUND COMMENTARY

South African fixed income delivered a solid performance in Q2 2026 as easing geopolitical tensions, lower oil prices and improving investor sentiment supported bond markets. Government bond yields traded in a relatively narrow range, with the 10-year yield remaining below levels seen at the start of the year as moderating inflation and expectations of further monetary easing underpinned demand. Globally, resilient US economic growth and uncertainty over the timing of Federal Reserve rate cuts kept developed market bond yields volatile, while concerns over elevated fiscal deficits limited the scope for yields to decline further. In South Africa, inflation remained well contained despite persistent administered price increases, supported by lower fuel costs and a relatively stable rand. With inflation expectations anchored and the South African Reserve Bank maintaining a cautious but accommodative stance, domestic bonds continued to offer attractive real yields, supporting a constructive medium-term outlook for the asset class.

Risk Indicator Definition

This portfolio can invest across the duration spectrum from money market to long bonds, which can result in capital volatility over the shorter term and deviation from the benchmark. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely. This portfolio typically targets a return in the region of 2% - 3% above inflation before tax over the long term.

Disclosure

The portfolio has adhered to its objective and there were no material changes to the composition of the Fund portfolio during the quarter.

Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
