Investment Strategy

The asset classes in which the fund managers invest include equities, fixed income, property (including Real Estate Investment Trusts), commodities, cash and cash like investments. The fund is invested across a broad spread of underlying assets, although equities and fixed income form the majority of the portfolio, with a maximum of 60% in equities. Exposure to equity and fixed income assets is typically through direct investment, and investments in property and commodities are indirect. The fund managers may also invest in shares in collective investment schemes covering global markets. The fund is invested in at least 100 individual investments. 

Equities
