Objective

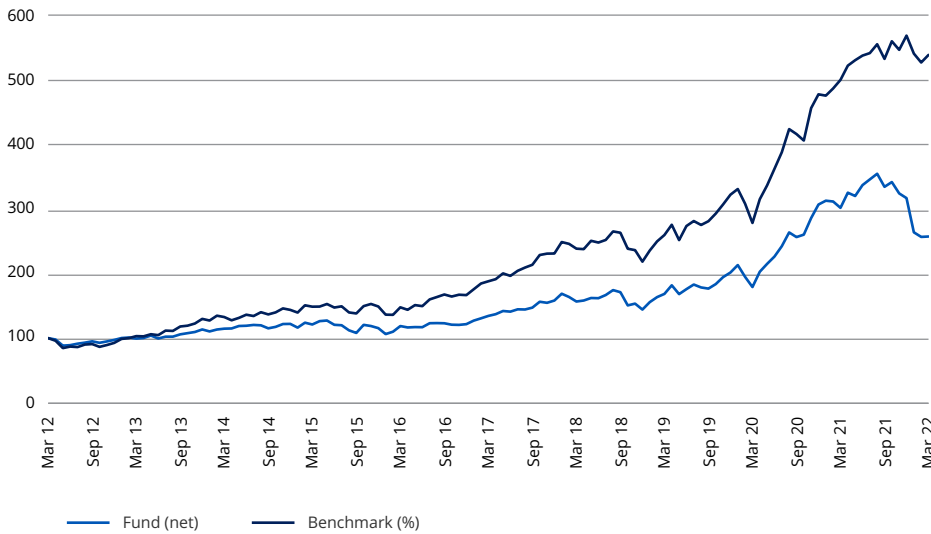
The Fund aims to achieve a combination of growth and income by investing in at least two-thirds in companies listed globally of all sizes whose business models are focused on and/or benefit from all forms of innovation.

The Fund aims to outperform the MSCI AC World Index (USD) benchmark before charges.

Portfolio securities

- The Fund will invest in at least two-thirds in equities and equity related securities of companies on registered stock exchanges.
- The Fund may also invest in other funds (including those managed by abrdn) and money-market instruments, and cash.

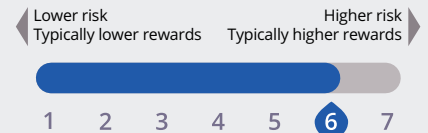

Management process

- The Fund looks to invest in the impact of innovation by breaking it into five pillars: How we live, How we make, How we save and spend, How we work and How we play, which are key pillars of human activity. By considering the impact of innovation via the five pillars, the Fund then looks to invest in companies that are using innovation to "improve" their businesses, "disrupt" existing businesses and "enable" innovation to occur.
- The benchmark is used as a reference point for portfolio construction and as a basis for setting risk constraints.
- In order to achieve its objective, the Fund will take positions whose weightings diverge from the benchmark or invest in securities which are not included in the benchmark. The investments of the Fund may deviate significantly from the components and their weightings in the benchmark.
- Due to the active nature of the management process, the Fund's performance profile may deviate significantly from that of the benchmark over the longer term.
