Abax Equity Prescient Fund is a domestic fund with a mandate to invest in listed South African equities.

The Fund's primary objective is to outperform the FTSE/JSE Capped Shareholder Weighted Index (Capped SWIX TR) over the medium to long term on a net of fees basis. A secondary objective is to outperform the peergroup (as measured by the ASISA General EQ SA Unit Trust Mean).

The Fund has a high risk profile, and is suitable for long term investors seeking high levels of investment growth, who can tolerate the associated high levels of capital volatility.

About the Fund

The Fund is actively managed and draws upon Abax's valuation-based security selection process.

The Fund is managed by Anthony Sedgwick, Marius van Rooyen, Omri Thomas and Steve Minnaar.


