

FUND OBJECTIVE

The Fund is a Collective Investment Scheme Feeder Fund which, apart from assets in liquid form, consists solely of participatory interest in the High Street Global Balanced domiciled in Ireland. The Fund invests predominantly in developed markets and targets an annual return of US Consumer Price Inflation plus 3-5%* over any rolling three-year period. It aims to achieve this by combining growth investments that are undervalued relative to their prospects with mature, dividend-yielding securities. Actively employing downside protection strategies and investing across asset classes mitigates large drawdowns while allowing for moderate capital appreciation.

INVESTOR SUITABILITY

The Fund is suitable for retail and institutional investors seeking capital gains with a moderate tolerance for market drawdowns. While volatility is expected to be less than an equity-only fund, investors must be willing to endure periods of short-term downturns. An investment horizon of 3+ years is recommended.



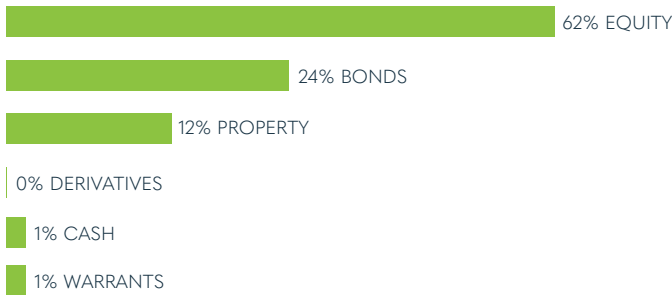

FUND COMMENTARY

The Fund returned -4.74% for the month of June relative to a benchmark of -4.15%.

The Federal Reserve Open Markets Committee (FOMC) maintained Short short-term interest rates at 5.25%-5.5% but expressed a hawkish stance and is considering an additional rate hike later this year. Although several inflationary pressures have eased, there are ongoing concerns, such as rising oil prices. These concerns are being partially tempered by a reduction of savings accumulated during the COVID-19 era, which could affect future consumer spending and result in a cooling of the economy.

Our technology holdings were the primary detractor during the month. Despite Adobe reporting earnings that exceeded expectations on both the top and bottom lines, the stock declined by 8.8%. This was due to a combination of the market anticipating a stronger outlook and concerns about a lack of pricing power shown for its new artificial intelligence powered software features. However, amidst this challenging market environment, Meta Platforms stood out as a relative outperformer, showing a gain of 1.7% off the back of promising prospects for future growth through increased monetisation of WhatsApp, Reels and Messenger in the coming quarters.

The stand out performer during the month was UnitedHealth, the largest healthcare and insurance provider in the United States. The insurer outperformed the market delivering a return of 5.8%. This was driven by the news that North Carolina would be expanding its Medicaid presence in the state, making an additional 600,000 low-income adults eligible for coverage.

The Fund's property component was negatively impacted by the high interest rate environment leading to weaker performances across the board. Within the fixed income component, our holding in Lowe's bonds matured. Proceeds from the sale were used to purchase Morgan Stanley bonds maturing in 2032, with a yield of 5.7%. This decision aligns with our strategy to extend the duration of the fixed income component taking advantage of the higher yields available to us. Furthermore, this positions us for potential capital appreciation should interest rates decline in the future.

In the quarter we had our holding in Lowes bonds mature and executed the sale of our shorter dated T-Bills which were set to mature in 2025. In order to maintain our fixed income exposure as well as extend our duration we made strategic decisions to purchase Philip Morris, Elevance Health and Morgan Stanley yielding 5.4%, 5.2% and 5.7% respectively. Bonds remain 24% of the Fund.

FUND SPECIFIC RISKS

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Feeder Fund: A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund

WHY IS THIS FUND IN CATEGORY 4?

The Fund is rated as 4 due to exposure to shares and stocks, and the nature of its investments which include the risks previously listed.
