Additional benefits are gained from efficient implementation of cash flows, dividend reinvestments, management of corporate actions and index rebalancing. The Fund aims to remain fully invested in property shares at all times.

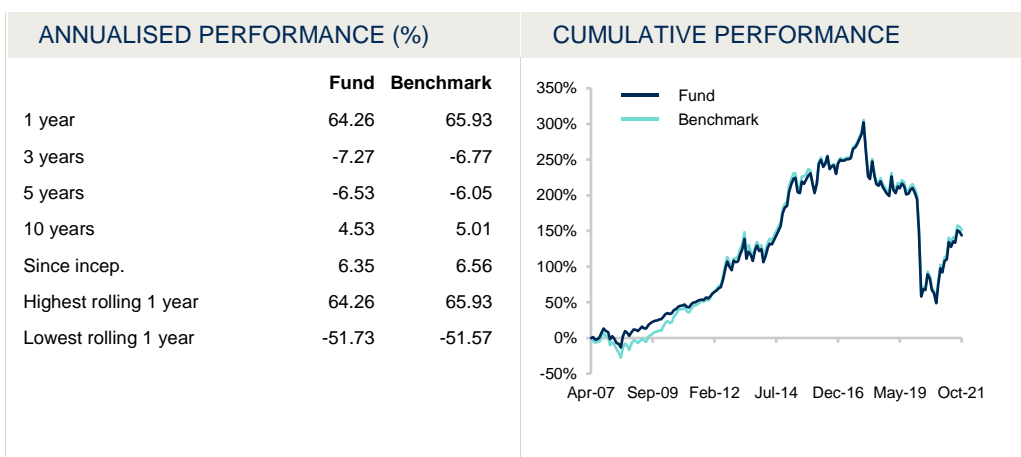
### WHO SHOULD INVEST

Investors who require exposure to SA listed property shares and who are comfortable with the volatility and potential short term capital losses that can result from exposure to property shares.

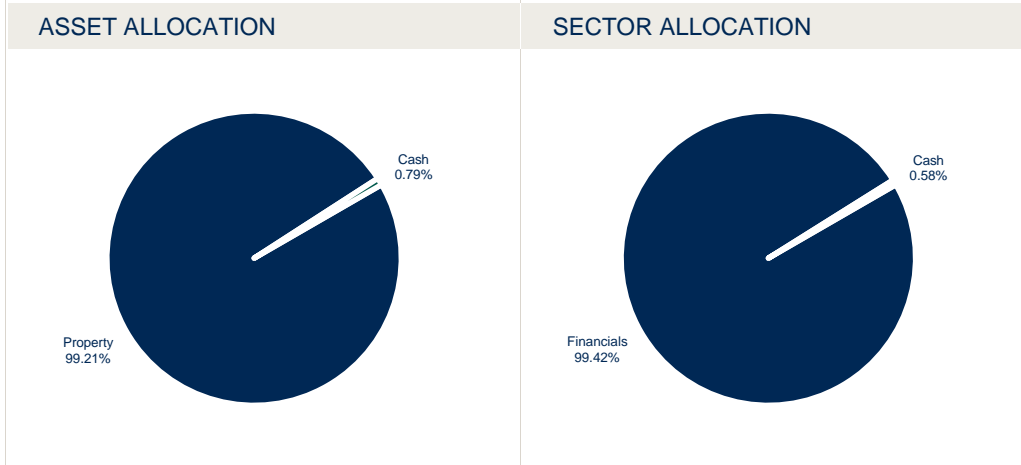
### RISK INDICATOR DEFINITION

## FUND COMMENTARY

October ushered in a corporate earnings reporting season which served as a positive catalyst for global equity markets as they staged an impressive recovery from what was a negative September. The MSCI World Index closed the month firmly in the green, up +5.66%. In addition to earnings, global markets were boosted by the progress on the Biden administration's social infrastructure plan. The market seemingly also looked past slow economic growth in favour of moderating inflation pressures with the S&P 500 Index up +7.01%. Strong earnings also had a positive effect on the European market in opposition to inflation concerns. This saw the Eurostoxx 600 Index post a healthy +3.75% for the month. In the east, China's CSI 300 Index and Japan's Nikkei 225 Index had conflicting performance, returning +1.49% and -4.18% respectively for the month. China's equity market was boosted by easing Evergrande led concerns that had plagued the region's property sector over the recent months. Japan's stock market's performance was mixed ahead of the upcoming general election at the end of October. Weakness in the Yen against the dollar, driven by anticipated policy divergence, resulted in a further negative performance for the month. The broader Emerging Markets also shared in the uptick of global markets although in smaller magnitude. The MSCI Emerging Markets Index closed the month up +0.99%.

Domestically, loading shedding and local government elections take the headlines for October. The rand gave back a further 1.15% during the month. The Resources sector recovered strongly, up +8.44% for the month. Financials were down -4.56% for the month whilst Industrials gained +6.73%.

The FTSE/JSE Africa SA Listed Property Index closed the month down -1.69%. The Prescient Property Equity Fund was behind the benchmark, down -1.86% (gross of fees) for the month.

### Contributors to Performance

The positions that contributed most to the absolute performance of the fund for the month were Irongate Group (+10.65%), Sirius Real Estate Ltd (+6.85%), and Equites Property Fund Limited (+2.60%).

### Detractors from Performance

The largest detractors from the month's absolute performance were Growthpoint Properties Ltd (-5.30%), Nepi Rockcastle PLC (-2.05%), and Fortress Reit Limited A (-3.06%).

## GLOSSARY

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**% Property risk:** Investments in real estate securities can carry the same risks as investing directly in real estate itself. Real estate prices move in response to a variety of factors, including local, regional and national economic and political conditions, interest rates and tax considerations.
