INVESTMENT AND RETURN OBJECTIVE

The Fund aims to consistently achieve returns above the (ASISA) South African General Equity category over the medium to long term. The Fund is managed systematically to outperform the peer group average return whilst maintaining similar risk characteristics.

INVESTMENT PROCESS

The Fund uses quantitative techniques to dynamically construct a portfolio that is most representative of the general equity category average then employs uncorrelated return enhancement techniques combined with efficient and cost-effective portfolio construction methods to generate outperformance. Although the fund is always fully exposed to the equity market, the use of fixed interest portable alpha techniques to enhance returns can provide exposure to cash and money market instruments, which are uncorrelated and reliable sources of additional return.

WHO SHOULD INVEST

Investors seeking broad based exposure to the South African equity market with consistently above average returns. This Fund is appropriate for investors with a long-term investment horizon.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

February was generally speaking a stellar month for global equity markets. Despite an array of downside risks and bearish rhetoric on the back of ongoing geopolitical conflicts, election uncertainties, and seemingly higher for longer interest rates, global equity markets have broadly continued to climb higher. In what has been its best start to a calendar year since 2019, the MSCI World Index gained 4.24% this month to reach new all-time highs. In the US, the S&P 500 Index firmly punched through the 5,000 level for the first time ever to close the month up a solid 5.34%. This was to a large extent helped by continued strong earnings numbers from the US, notably in the technology sector, and resilient consumer-led economic data. Looking across the pond, while still registering a positive return for the month, Europe lagged behind the rest of the developed world with the Euro Stoxx Index gaining 2.72% for the month. In Asia, Japan again showed impressive performance, the Nikkei 225 returned 5.32% in dollars. This was despite a lower-than-expected growth number, as exporter companies are seemingly poised to benefit from a depreciating Yen. Emerging Markets equities had a remarkable rebound during the month and made back most of the losses suffered in January. The MSCI Emerging Markets index closed the month up 4.76% to bring the year-to-date return to -0.11%. This was mostly driven by China where the interventions by the government in support of the markets are bearing fruit.

Domestically, the equity market lagged general emerging market counterparts. The Minister of Finance tabled the 2024 budget in which a commitment to reduce borrowings debt servicing costs by utilising accumulated profits from the nation's Gold and Foreign Exchange Contingency Reserve Account was made. Initial market reaction was positive, however, the Rand eventually continued to weaken, 2.78% weaker for the month and 4.58% weaker year to date. Resources led the decline by losing 7.17%, whilst Financials and Industrials lost 0.85% and 0.64% respectively.

The Fund Benchmark closed the month down 1.47%. The Fund was behind the benchmark, down 2.30% (gross of fees) for the month.

Contributors to Performance:

The positions that contributed most to the absolute performance of the Fund for the month were Cie Financiere Richemont SA (+8.94%), Multichoice Group Ltd (+39.21%) and AngloGold Ashanti Plc (+6.80%).

Detractors from Performance:

The largest detractors from the month's absolute performance were Gold Fields Ltd (-9.36%), MTN Group Ltd (-12.60%), and FirstRand Ltd (-4.62%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
