The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to investors with a short-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.



FUND COMMENTARY

At their March 2024 sitting, the Monetary Policy Committee (MPC) of the South African Reserve Bank (SARB) decided (unanimously) to keep the key bank policy rate, the nominal repurchase rate, unchanged at its current level of 8.25% per year.

According to the SARB, relative to many other emerging and advanced economies, the rise in South Africa's headline inflation rate was more gradual and peaked lower. However, the return to target has been slow. The inflation rate remains sensitive to changes to both global and domestic supply and demand.

The latest inflation figures indicate a further deviation from the SARB's target of 4.5%, as the headline rate increased to 5.6% in February. The current value falls closer to the upper limit of the desired range (3.0%-6.0%) rather than the midpoint. The core inflation rate also increased to 5.0%.

The SARB anticipates a return of headline inflation to 4.5%. Nevertheless, due to the presence of supplementary inflationary pressure, the overall inflation rate now attains the desired midpoint only by the end of 2025, which is later than initially anticipated.

The 12-month NCD rate widened by 5bps and the 3-month Jibar rallied close to 2bps over the month.

The Fund is still well positioned to take full advantage of the cycle with our step rate notes resetting at levels significantly above bank FRN spreads. This coupled with quality credit, continues to see the Fund outperform its benchmark.

The Fund had a good performance month during January. The positive yielding assets added to the return for the month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.
