FUND OBJECTIVE & STRATEGY


The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activits bias.

QUARTERLY COMMENTARY | MARCH 2025

Master Drilling delivered record numbers with revenue up 11.5% in USD, dividend up 23.8% and a record pipeline of \$696m. The exciting news, however, is that African Rainbow Minerals is starting a new non-explosive mine at Bokoni Platinum which involves the use of the Master Drilling Horizontal Tunnel Borer and the new technology reef-boring machine. The Reef Borer removes 800mm of reef mechanically without explosives and reduces the amount of waster ock that needs to be moved to the surface. Processing only reef reduces the size of the processing plant and reduces water, electricity and chemical usage, which significantly improves the profitability of the mine and could have significant implications for mining in the future.

ASP Isotopes announced the start of production of Ytterbium 176 - an isotope used to produce a revolutionary new oncology drug called Pluvicto, which is manufactured by Novartis. What's very significant about this announcement is that the laser technology used to enrich YTI76 is the same method used to enrich Uranium 235 used in nuclear fuels. This new laser technology, called Quantum Leap Energy and developed in Pretoria, costs a fraction of the \$6bn needed to build the old WW2 centrifuge enrichment technology the West now desperately lacks.

Outside of company-specific news, markets are in a mess as we write this note but there are a couple of things we believe are important to keep in mind. US Tariffs are clearly a tax on US consumption of hard goods, which are typically 10% to 20% of consumer spending - prices will rise and demand will be dampened which increases the likelihood of a recession in the Unites States. Americans don't take inflation, unemployment and economic hardship as well as us Africans and Trump needs to ensure that the US economic juggernaut is delivering before the US mid-term elections in November 2026. Keep in mind that the average US recession lasts 17 months - that's awfully close to the mid-term elections in 2026. Tipping the US into recession now increases the likelihood of the Democrats taking control of the Senate. The second guard rail is US Treasuries - the US Fed has \$35 trillion of debt, of which \$9 trillion needs to be rolled in 2025. The last thing Trump needs is rising interest rates as this impacts main street America and his voter base. So keep in mind the old Persian adage: **This too shall pass**.

The Fund has adhered to its policy objective. The number of participatory units at 31 March 2025 was 54 481 854. The current asset allocation versus the previous guarter is as follows:




