INVESTMENT AND RETURN OBJECTIVE

The Fund aims to outperform both JSE All Bond Index and the STeFI Call Index over time, utilising active bond and cash management combined with strategies which aim to reduce risk over time.

INVESTMENT PROCESS

The Fund invests in cash and high-quality capital market instruments. A number of techniques are used to generate returns, including duration management, yield enhancements via credit exposure and risk management strategies, where these strategies are designed to provide downside protection.

WHO SHOULD INVEST

Investors requiring a specific allocation to the bond market but is prepared to give the fund manager some discretion to exercise his views on value in the bond market. This Fund is Reg. 28 compliant.

RISK INDICATOR DEFINITION

This portfolio can invest across the duration spectrum from money market to long bonds, which can result in capital volatility over the shorter term and deviation from the benchmark. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely. This portfolio typically targets a return in the region of 2% - 3% above inflation before tax over the long term.

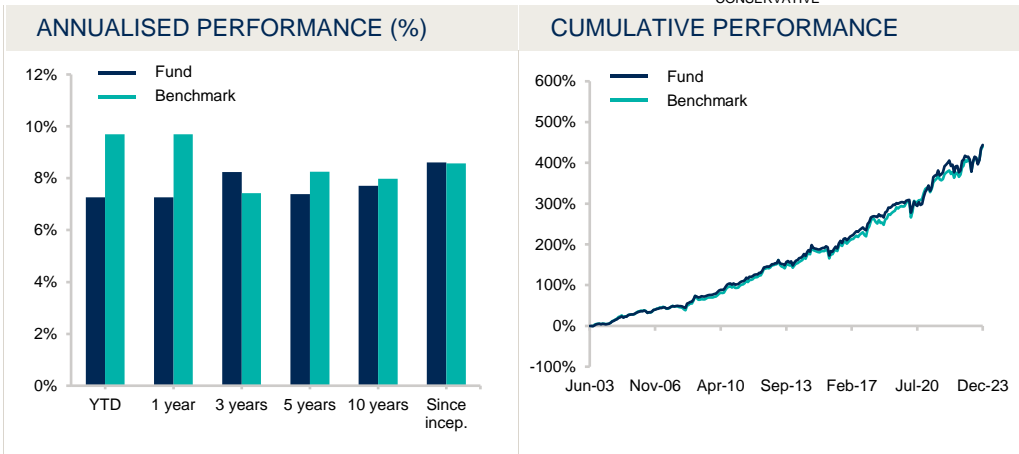

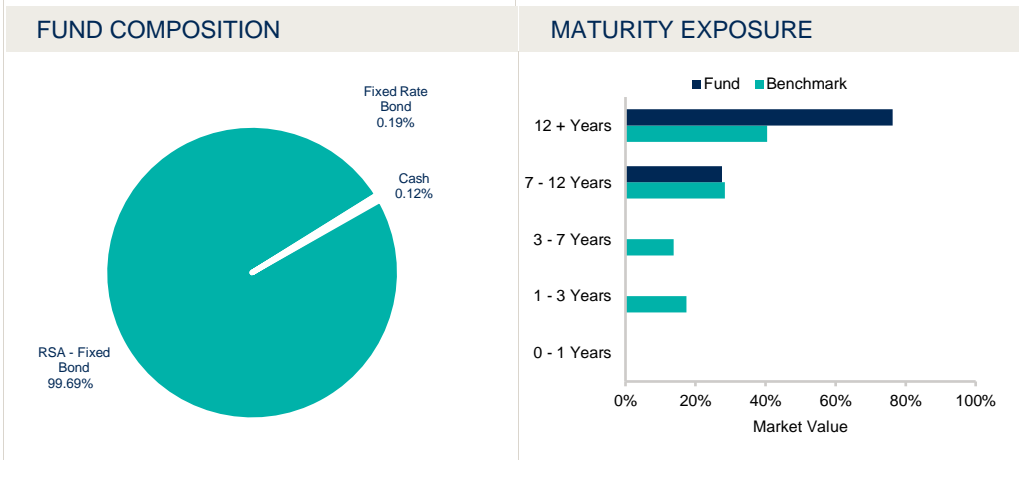

FUND COMMENTARY

In the final two months of 2023, global capital markets oscillated: long-term yields initially surged and then retreated on investors' evolving perceptions of future central bank policy actions. After reaching highs in some cases not seen since the run-up to the Great Financial Crisis (GFC), yields declined rapidly in November 2023. Developments in risky asset markets, as well as exchange rates and capital flows in emerging market economies, were closely intertwined with the evolution of core bond markets. The path of long-term yields reflected market participants' strong reactions to statements by public authorities and news about the economic outlook.

With inflation slowing, nominal and real yields followed similar paths in major advanced economies. Long-term yields had previously been under upward pressure from rising term premia, amid expectations of an increased supply of long-term debt, as announced by the US Treasury. The rise in yields accelerated following the September Federal Open Market Committee (FOMC) meeting, as investors began to expect policy rates to stay high for longer than previously anticipated. Fixed income markets reversed course during the latter stages of 2023, when investors interpreted central bank communication and macroeconomic data releases as suggesting an earlier end to the hiking cycle. In addition, pressures on term premia eased on announcements of lower-than-expected issuance of long-dated US treasuries.

The local nominal Bond market was up 1.49% on a total return basis for December, with the 7 to 12-year segment of the curve outperforming. The inflation-linked Bond market was up 2.19% over the month.

The Fund outperformed its benchmark over the month, and currently offers a gross yield of 11.81% p.a. with the equivalent measure for the All Bond Index being 10.84% p.a.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.

Liquidity risk: If there are insufficient buyers or sellers of particular investments, the result may lead to delays in trading and being able to make settlements, and/or large fluctuations in value. This may lead to larger financial losses than expected.

It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
