

# PRESCIENT INCOME PLUS FUND (A2)

## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return STeFi Call + 3% per annum through a full interest rate cycle by offering investors an enhanced income yield without undue risk on capital by maintaining constrained credit risk exposure.

### INVESTMENT PROCESS

The Fund invests in a diversified portfolio consisting primarily of South African vanilla debt, mezzanine and structured instruments across the term structure and credit rating bands. Portfolio risk is managed at both single issuer and portfolio level. The former is done through an inhouse dynamic probability of default (PD) based rating model and the latter is through measuring the Expected Loss (EL), Loss Given Default (LGD) and credit VaR (Value at Risk). The Fund's modified duration is limited to two years. Credit asset selection is underpinned by minimising default risk and credit spread duration.


### WHO SHOULD INVEST

Investors seeking performance in excess of what is available in the money market or a typical income fund. The Fund is not Regulation 28 compliant.

### RISK INDICATOR DEFINITION

This portfolio typically has longer dated and complex credit exposures, resulting in some capital volatility and liquidity constraints to investors over the shorter term. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely, and in a manner that would cater for client redemptions appropriately.

## FUND COMMENTARY

Primary market activity was significantly reduced at R5.8bn for October 2021, down from the R10.6b reported in the prior month, as we saw fewer auctions. Key issuance during the month came from Standard Bank Group (Additional Tier 1 Capital "AT1") and Capitec (Senior Unsecured). Both auctions attracted decent demand, with Standard Bank issuing R1.7b (vs. demand of R3.3b), below guidance. Interestingly, this was the first AT1 issuance below 400bps. Similarly, Capitec issued R750m (vs. demand of R1.45b), at the bottom end of guidance. With regards to the secondary market, we continue to see buyers of bank AT1 instruments, and improved activity in the State-Owned Entity and municipal space. The current Prescient credit theme, as determined by a combination of the output of our Credit Cycle Indicator, our consideration of individual counterparty default probabilities, and finally, the yields offered on these opportunities, is one of "elevated risk levels with suppressed yields". Given this view, we continue to be very selective in what we buy, with our fund targeting investments in defensive sectors. Our short- to medium-term bias remains, while remaining cognizant of credit spread duration. While noting our risk/return theme, we continue to add new listed and unlisted opportunities to the fund, and have marginally increased the fund's Modified duration, as supported by our bond house view. The Fund's 1 year performance of 7.58% is reported. The fund's Modified Duration is at 1.67yrs with a weighted term to maturity of 4.2 years. The fund reported a month-to-date positive net return of 29.9bps.



## GLOSSARY

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Forward Yield:** The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

**Interest rate risk:** The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
