

## Fund Objective

The fund will, apart from assets in liquid form, consist solely of participatory interest in the approved, Sigma Select Global Leaders Fund under the Prescient Global Funds ICAV, an open ended umbrella fund with segregated liability between funds, domiciled in Ireland. The investment objective of the underlying fund is to outperform the Benchmark, as measured by the MSCI ACWI, over the long term. The underlying fund will seek to achieve its objective primarily through investing of up to 100% of its net assets in global equities which are listed or traded on Recognised Exchanges, or subject to the investment restrictions set out in the supplement.

## Fund Strategy

The Fund capital is allocated to a carefully considered blend of independently managed global and specialist equity strategies.

The Fund is constructed by optimally blending the various manager styles and strategies to achieve the return target over the long-term.

A rigorous investment process underpins the identification and selection of managers according to their key strengths and specialisation.

These managers include the best active stock-pickers that the fund manager has encountered globally and they all have long term track-records of successfully generating superior returns for their investors.

Each manager is constantly assessed relative to their appropriate benchmarks and must consistently comply with the fund manager's stringent due diligence criteria.

The Fund exposure is constantly monitored and reviewed, and may be adjusted from time to time, having regard to the prevailing market conditions.

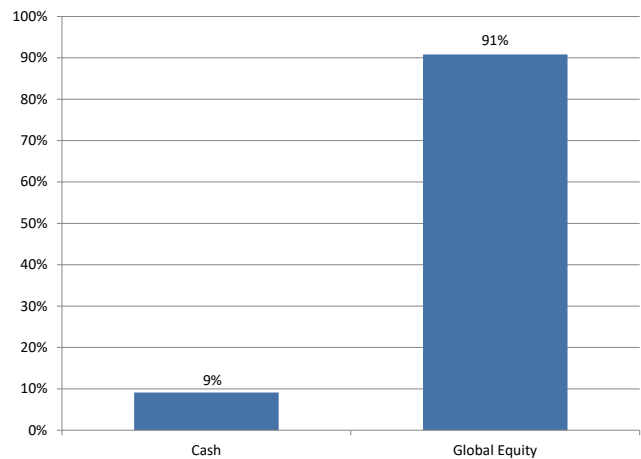

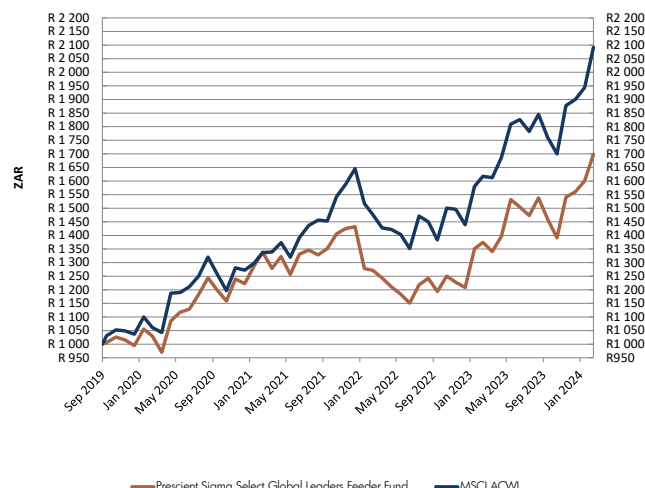

### Quarterly Commentary - Q4 2023

Global risk assets ended the year on a high note supported by a growing consensus among investors that the major central banks might commence interest rate reductions sooner than initially anticipated. The MSCI All Country World Index (ACWI) returned +11.2% in US\$ during the fourth quarter, capping off a strong 2023 in which the index increased by +22.8%.

The Sigma Select Global Leaders Fund marginally underperformed the MSCI ACWI over the quarter, returning +10.4% to take the year-to-date return to +20.4%. The change in the expected interest rate trajectory provided support for the Sands Global Growth Fund (8% of the Fund), which was the top performer during the quarter, delivering a positive return of +20.1% in US\$. The Fund's slight overweight to the Asian market detracted from the relative performance, with the Platinum Asia Fund returning a relatively muted +3.0% in US\$.

Inflation levels continued to fall in the major developed markets as falling energy costs benefitted the headline prints. The annual headline inflation rate in the US decreased to 3.1%, down from 6.4% at the end of 2022. The Eurozone and the UK similarly experienced significant decreases during the year, ending the year with annual inflation rates of 2.9% and 3.6%, respectively.

With inflationary pressures seemingly easing, all the major central banks kept their policy rates unchanged during the quarter, hinting that they could be close to the peak. The minutes from the December FED meeting had a more dovish stance, with the revised dot plot anticipating three rate cuts in 2024, up from two cuts at the previous meeting. While having a less dovish stance, the ECB and BOE acknowledged anticipated rate cuts in 2024, albeit later in the year to keep inflation pressures under control.

Despite the US Dollar weakness, Emerging Markets underperformed Developed Markets as concerns about the Chinese market persisted and weighed on sentiment. The MSCI Emerging Market index returned +7.9% in US\$ to take the year-to-date return to +10.3%.

Going into 2024, the MSCI All Country World Index is trading on a forward Price to Earnings (P/E) ratio of 16.6 times, slightly above its long-term average of 15.8 times. From a valuation standpoint, this appears to be fairly priced, and based on historical trends, offers the potential for attractive real returns over the next five years.

However, a degree of caution is warranted given the optimistic earnings growth projections for 2024, with analysts forecasting corporate earnings to grow by an above-average rate of 10% during the year. The forecasts are higher for some of the mega-cap US technology companies, with expectations that the "magnificent 7" companies will grow earnings by an average rate of 25% during 2024. We remain cautious on some of these large-cap US companies, particularly given their frothy valuations.

Within the index, the disparities widened further during 2023, providing an attractive opportunity set for the valuation-driven strategies within the Sigma Select Global Leaders Fund.

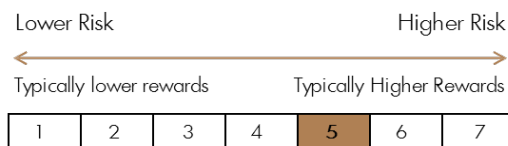
Looking ahead, we anticipate heightened levels of volatility in 2024 propelled by the increasingly opaque economic outlook, the impact of Middle Eastern and Ukraine/Russia conflicts and the political uncertainty, notably in the US. Nonetheless, we have full confidence in the expertise and agility of our active managers to navigate these market conditions and capitalise on compelling opportunities.

The Fund remains well diversified across regions, with a slight overweight to Asia and Japan, and underweight to the USA.

The portfolio has adhered to its policy objective as stated in the supplemental deed.

## Fund Specific Risks

In addition to the risk captured by the indicator above, the overall Fund value may be considerably affected by:

- **Default risk:** The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

## Glossary Summary

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest and Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Sharpe Ratio:** The Sharpe Ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**%Positive Month:** The percentage of months since inception where the fund has delivered positive return.

**Volatility:** Volatility is a statistical measure of the dispersion of returns for a given security or market index.

**Feeder Fund:** A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.
