Investment Strategy

At least 90% of the fund is invested in a portfolio of shares in property companies, including Real Estate Investment Trusts, in the UK and Europe. Investments are spread across different sub-sectors which may include offices, retail, residential, leisure and healthcare. The fund is further diversified by geographical location across Pan-European countries and by company size, from very large companies to smaller ones. The fund managers assess the economic environment and property market conditions to help determine the attractiveness of the countries and sub-sectors. This includes analysis of economic growth, interest rates and inflation as well as the demand for and supply of property across the region. 

Other information

This fund is priced on a swing pricing basis. A swing pricing is where the price can swing to either a bid or an offer basis depending on the investment and redemption activity in the fund. This means the investor selling or buying fund

shares bears the associated [dis] investment costs and protects the continuing holders in the fund. Performance could be shown on a combination of bid, mid or offer prices, depending on the period of reporting.

Equities
