FUND INVESTMENT SUMMARY AND OBJECTIVES

Our Investment Strategy and Philosophy

Shares are evaluated, not by a fluctuating ticker or a graph on a screen, but by what they represent, a certificate of ownership. We seek great businesses that are well run and managed, trading at a discount to their intrinsic value. We follow the adage that the return of an investment is determined not by the exit price but by the price one pays.

Fund Objective

The Aylett Equity Prescient Fund is a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms.

The Fund adhered to the investment policy objectives as stated in the Supplemental Deed.

Fund Universe

The Aylett Equity Prescient Fund is required to invest a minimum of 80% of the portfolio in equities at all times, with offshore asset exposure being limited to 45%

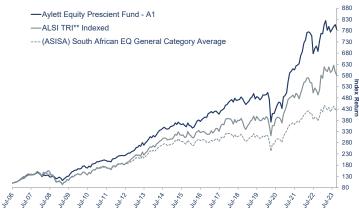

AYLETT EQUITY PRESCIENT FUND vs JSE ALL SHARE TRI PERFORMANCE (Net of fees)



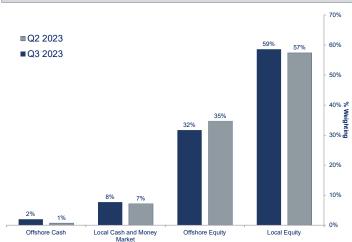

FUND MANAGER COMMENTARY

MARKET REVIEW

For the quarter ended Sept 2023, the JSE All Share declined -3.5%, the ALBI was down -0.4% and cash returned +2%. The South African equity market marginally underperformed the ACWI global index, which declined -2.8% in ZAR for the quarter. The rand weakened slightly during the quarter, starting the period at 18.76 and finishing at 18.92.

Year to date the JSE All Share has returned a total of +2.2%, the ALBI is up +1.5%, and cash has returned +5.8%. The ACWI global index returned 22.5% in ZAR.

FUND PERFORMANCE

Over the quarter, the fund was down 0.09%, outperforming its benchmark by 3.4%. Year to date, the fund has returned 2.5%. Contributors to performance for the quarter were AECI, Sabre, ConocoPhillips, Curro, and Southern Sun. Detractors to performance were Spirit AeroSystems, Transaction Capital, Impala Platinum, Melco and Bath & Body Works.

NOTABLE CHANGES TO THE FUND

During the quarter, as it reached full value, we completed the sale of the remaining shares in Woolworths, our only exit. We have started to build a position in a South African midcap, details of which we can share once the position is established.

OUTLOOK

US rates continue to rise and will act as a headwind for asset prices. In theory, this should be particularly pronounced for long-duration assets. The portfolio is somewhat protected with its bias towards cash-generative assets, offering a faster return on investment.

The global energy transition remains an area of interest for us. It is evident that while political rhetoric around green initiatives sounds promising, the real-time repercussions of such policies on the daily lives and economic standards of the populace are just beginning to unravel. Politicians have been quick to reverse course when the implications of said green policies start to sway voter preferences. Any slowdown in the energy transition will aid energy prices and, by extension, platinum group metals.

The outlook for deploying capital in South Africa is mixed. There is likely to be a tightly contested election next year, bringing considerable uncertainty. Uncertainty is never good for equity valuations. South Africa's fiscal situation is of increasing concern with a shortfall in tax collections, primarily attributed to lower corporate taxes due to falling commodity prices (notably coal and PGMs) and the adverse effects of loadshedding on business profitability. While tax take disappoints, government expenditure continues to exceed the Treasury's estimates, notably in social grants and public sector wage hikes. The growing deficit has to be funded somehow and given the proximity to the upcoming elections, a cut in government spending seems improbable. That leaves more borrowing and higher taxes to plug the hole. This doesn't bode well for the health of the South African consumer. Offsetting these headwinds is a much-improved outlook for loadshedding, which we expect will improve over the next 18 months, and provide some economic respite. Interestingly, market sentiment seems closely linked to loadshedding. Domestic businesses are cheap by historical standards and often much cheaper than their offshore peers. The question that occupies much of our day is how much of the above is priced into local equity valuations.

As one would expect considering the muted return from the fund since our last quarterly commentary the latent value in the fund remains significant. We own good businesses, run by competent management skilled at navigating the challenging local conditions, at prices that compensate us for the risk inherent to each. Cash currently earns an attractive return, meaning we're paid to wait to take advantage of any volatility, locally or offshore, in the coming months.
