### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to generate real returns in US Dollars and is benchmarked to the US inflation rate.

### INVESTMENT PROCESS

The investment universe includes fixed, floating, real and nominal money market and bond market investments, derivatives and global currencies. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, the use of derivatives and currency management.

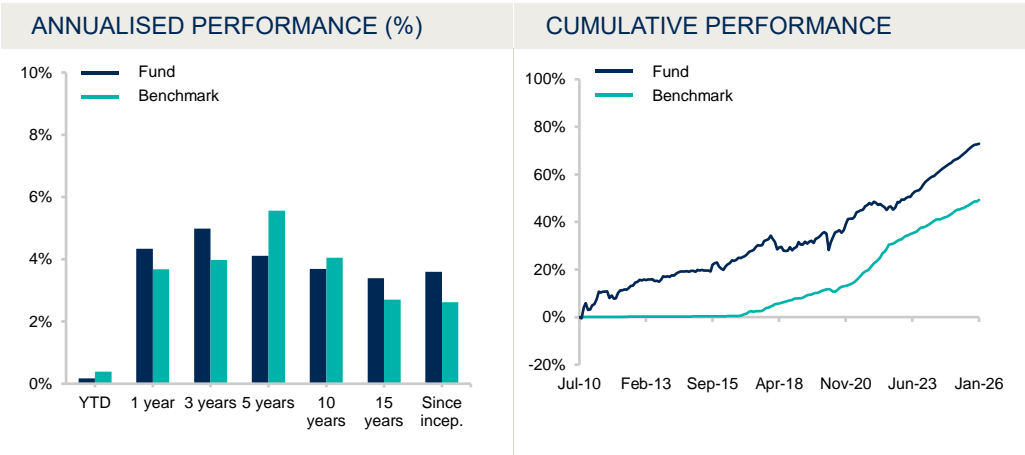
### WHO SHOULD INVEST

Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally in South Africa. Although this is a roll-up fund and does not distribute income, it is suitable to investors with a medium to long-term investment horizon who wishes to fund income withdrawals by redeeming units, due to the exposure to yield generating assets held in the Fund and therefore a lower probability of selling underlying units at inappropriate times such as in a market downturn.

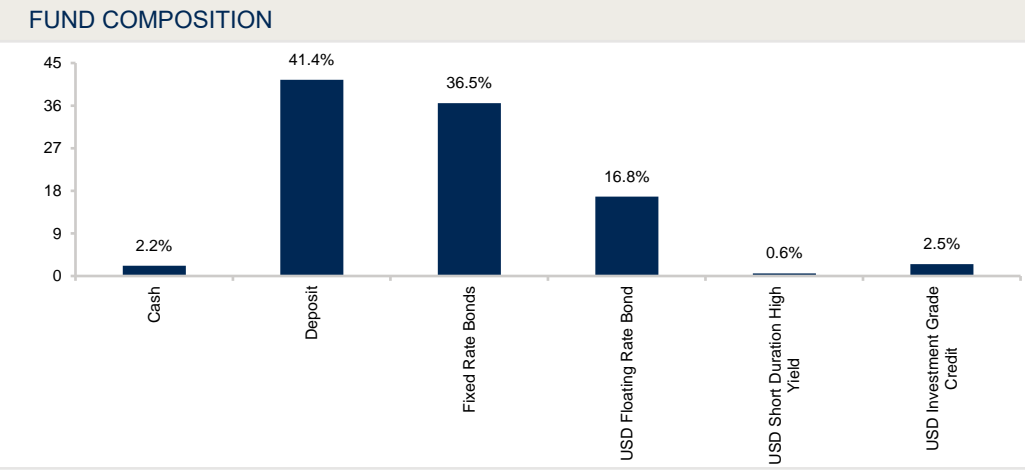
### RISK INDICATOR DEFINITION

This portfolio typically has no equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses in USD terms over the shorter term unlikely. This portfolio typically targets a return in the region of 1% – 3% above US inflation over the long term.

## FUND COMMENTARY

Global fixed-income markets began 2026 on a steady and constructive footing as confidence continued to build that major central banks are approaching the later stages of the tightening cycle. In the United States, ongoing moderation in inflation and further signs of cooling in the labour market reinforced expectations that the Federal Reserve is progressing along a gradual, data-dependent easing path over the course of the year. US Treasury yields were broadly stable in January, with modest moves led by the front end as markets balanced easing expectations against still-resilient economic activity.

Across other developed markets, central bank communication remained cautious but increasingly supportive of duration, with policymakers emphasising progress on inflation while retaining flexibility in the pace of policy normalisation. Overall rate volatility declined, contributing to a more supportive backdrop for global fixed-income assets.

Credit markets remained resilient during the month. Investment-grade spreads were broadly unchanged and remain near cycle lows, supported by strong balance sheets and continued demand for high-quality income. High-yield markets also held firm, benefitting from improved risk sentiment and lower volatility, although valuations remain tight and issuer selection continues to be a key driver of returns.

Within the Fund, we maintained a disciplined and diversified approach to global income allocation. Positioning continues to favour high-quality assets, with an emphasis on floating-rate and shorter-duration exposure where carry remains attractive and capital volatility is lower. At the same time, the Fund retains flexibility to selectively add duration as policy easing becomes more clearly established. Overall positioning remains balanced, prioritising capital preservation, stable income generation, and the ability to capture opportunities as global rate cycles evolve through 2026. We continue to hold our duration in the US5 and US10 year treasuries.

The Fund's forward yield remains attractive at 4.86%, with an interest rate duration of 1.74 years. The portfolio's current risk portfolio aligns with the Fund's risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Fund had positive performance in January albeit below the benchmark. Key drivers of performance included the higher yielding assets in the portfolio, and the front end focussed yields. The added duration detracted for the month with US bond drifting higher. The Fund remains well positioned to achieve its risk and return targets.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

**Forward Yield:** The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
