

Investment Objective

The portfolio aims to provide investors with moderate capital growth by achieving returns in excess of the benchmark. The portfolio will be subject to the Prudential Investment Guidelines for retirement funds in South Africa to the extent allowed for by Regulation 28 of the Pension Funds Act, or such other legislation published from time to time.

Investment Policy

The objective of the **Resolute Balanced Prescient Fund of Funds** is to provide investors with moderate capital growth.

In order to achieve the objective, the underlying portfolios may invest in, amongst others equity securities, property securities, money market instruments, preference shares, bonds, other interest-bearing instruments and other listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time. To provide a limited level of capital protection, the portfolio is allowed to have a maximum equity exposure of 60% of the portfolio's net asset value. The maximum offshore exposure shall be 45%.

Glossary Summary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request. Annualised performance is net of fees.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Sortino Ratio: Measures risk-adjusted return by focusing only on downside volatility — a higher figure means better returns for the downside risk taken.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

Fund Specific Risks

Default risk: The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuer's credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Developing Market (excluding SA) risk: Some of the countries invested in may have less developed legal, political, economic and/or other systems. These markets carry a higher risk of financial loss than those in countries generally regarded as being more developed.

Foreign Investment risk: Foreign securities investments may be subject to risks pertaining to overseas jurisdictions and markets, including (but not limited to) local liquidity, macroeconomic, political, tax, settlement risks and currency fluctuations.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence, their value decreases when interest rates and/or inflation rise.
