INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver long term capital growth over time by offering a well-diversified portfolio investing in a broad range of domestic only asset classes in a balanced manner. The Fund will typically have high exposure to equities although some tactical asset allocation will be performed.

INVESTMENT PROCESS

The Fund invests in South African markets only across a diverse range of domestic only equities, property and interest-bearing instruments. Asset allocation is managed actively, anchored at the long-term strategic asset allocation but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

WHO SHOULD INVEST

South African investors seeking long term capital growth by investing in a typical, market related domestic balanced portfolio. The Fund is suitable for investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically exhibit more volatility and potential for capital losses due to higher exposure to equities and exposure to offshore markets where currency fluctuations may result in capital losses. These portfolios typically target returns in the region of 5% - 6% above inflation over the long term.

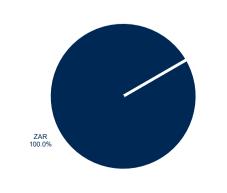

FUND COMMENTARY

U.S. President Donald Trump has announced that a 30% tariff will be imposed on all goods imported from South Africa, with the measure set to take effect on 7 August. However, he clarified that no tariffs would apply to South African companies that choose to manufacture their products within the United States. In addition, certain exceptions will be made for minerals deemed critical to U.S. national interests - specifically platinum group metals (PGMs), gold, chrome, and coal. At present, South Africa is still awaiting a formal response to its trade proposals submitted to the Trump administration, and it remains uncertain whether a deal will be reached before the 7 August deadline. Without a resolution, South African exports to the U.S. could become significantly less competitive, leading to widespread consequences for the domestic economy. Trump has also threatened to impose an additional 10% tariff on imports from any country that aligns itself with BRICS, the intergovernmental group comprising Brazil, Russia, India, China, and South Africa.

While negotiations between South Africa and the U.S. remain unresolved, the U.S. recently secured a framework trade deal with the European Union (EU), effectively averting an escalating trade conflict between the two major economies, which together account for nearly one-third of global trade volume. Under the deal, the U.S. will impose a 15% tariff on EU goods, while the EU has agreed to significantly increase its purchases of U.S. energy and military equipment.

Meanwhile, monetary policy developments are adding another layer of complexity to South Africa's economic outlook. The South African Reserve Bank (SARB) convened on 31 July and, contrary to market expectations for a rate hold, decided to lower the repo rate by 25 basis points to 7%. This decision came amid a modest increase in inflation to a four-month high, though it remains well below the midpoint of the SARB's 3-6% inflation target band. The central bank has indicated that its long-term aim is to gradually shift toward a 3% inflation target, suggesting that further rate cuts may be on the horizon to stimulate domestic growth, even as consumer demand remains weak.

In the United States, the Federal Reserve (Fed) wrapped up July with no changes to its benchmark interest rate, maintaining a cautious "wait-and-see" approach. The last rate cut occurred in December 2024, when the Fed reduced rates by 25 basis points. The Fed's decision to hold steady this month reflects ongoing uncertainty in the economic outlook, particularly surrounding the inflationary effects of the Trump administration's aggressive trade measures. Notably, two Fed governors voted in favour of a rate cut, marking the first dissent of this kind since 1993 - an indication of growing division within the central bank. President Trump has continued to pressure the Fed to ease policy further, arguing that inflation remains subdued and that additional stimulus would bolster U.S. economic competitiveness.

The equity market generally had a positive performance for July. Although most indices underperformed compared to last month, they still posted positive gains for the month, reflecting the market's resilience amid external uncertainties, particularly ongoing trade conflicts. Emerging Markets outperformed developed markets, with the MSCI EM gaining 1.67%, while the MSCI World rose by 1.23%. The U.S. Dollar continued to strengthen, with the Dollar Index Spot (DXY) gaining 3.19%, whereas the South African rand weakened further against the dollar. Locally, the FTSE/JSE All Share Index rose by 2.27%, although its gains were partly offset by detractors mainly from the industrials sector.

On the fixed income side, the local bond market performed well, with the FTSE/JSE ALBI Total Return Index gaining 2.28%. In contrast, U.S. Treasuries experienced a modest loss of -0.39%. Notably, Japan's 10-year government bond yield rose to 1.56%, the UK's 10-year yield climbed to 4.53%, while the U.S. 10-year Treasury yield slightly dropped by 1 basis point to 4.22%.

The Fund currently holds a moderately negative view on South African equity and a neutral view on South African bonds.

Fund performance was positive for the month due to the continuing rally in South African equity.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.
