INVESTMENT OBJECTIVE

The fund aims to create income and long term capital growth within the constraints governing retirement funds. The fund aims to outperform the market average of similar unit trusts without taking on more risk. The funds benchmark is the market-value weighted average returns of funds in the South African – Multi Asset – High Equity category.

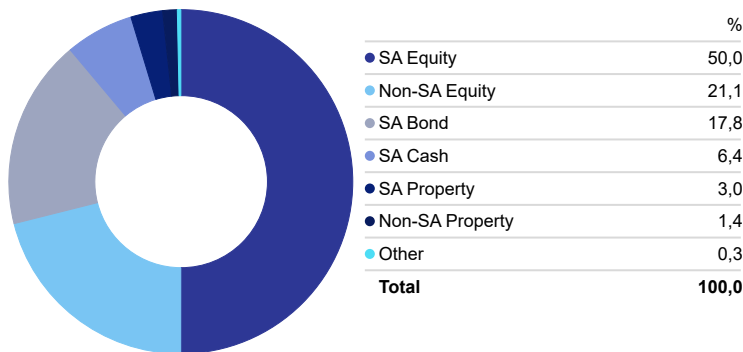
INVESTMENT POLICY

The Fund invests in a mix of shares, bonds, property, commodities and cash. The Fund can invest a maximum of 30% offshore, with an additional 10% allowed for investments in Africa outside of South Africa. The maximum net equity exposure of the Fund is 75% and we may use exchange-traded derivative contracts on stock market indices to reduce net equity exposure from time to time. The Fund is managed to comply with the investment limits governing retirement funds. Returns are likely to be less volatile than those of an equity-only fund.

HOW WE AIM TO MEET THE FUNDS OBJECTIVE

The management team track the asset allocation of reputable asset managers with large research capabilities. The research provides insight into where top professionals are allocating assets. We build portfolios in line with these allocations and select ETF's, mutual funds and shares in companies as the underlying instruments. The fund will allocate a to a diverse balance of active & passive management strategies as well as towards asset managers with a core competency. 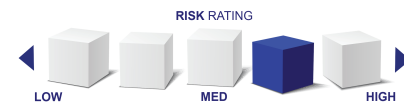

MODERATE - HIGH RISK

FUND COMMENTARY

The Interactive Balanced Prescient FoF A returned +5.88% in the second quarter of 2025, supported by strong performance across local equity, property, and diversified global equity allocations. Its broad, balanced exposure helped navigate ongoing market volatility and benefit from improved sentiment both locally and offshore.

Key contributors on the local equity side included Satrix Top 40 Index (+10.24%), Fairtree SA Equity Prescient (+8.31%), and the newly introduced Interactive Equity Prescient Fund (+5.41%). These strategies benefited from a rebound in investor confidence, supported by falling inflation, stabilising interest rate expectations, and a more constructive fiscal outlook in South Africa. Dividend-focused equities also added positively, with Satrix Dividend Plus Index (+8.18%) delivering strong returns on the back of solid earnings and a favourable yield environment.

Property allocations were another key driver of performance. Harvard House BCI Property (+9.23%) and Satrix Property Index (+9.04%) both performed well, reflecting renewed demand for income-generating assets and a more stable interest rate outlook.

On the global side, the Interactive Global Equity Prescient Fund of Funds (+4.93%) added positively, supported by a broad recovery in international equity markets and strong returns from global technology holdings.

Defensive assets continued to play an important role. The Interactive Income Prescient Fund (+2.83%) added stability amid rate uncertainty, while Sesfikile BCI Global Property A (+0.56%) was the only notable laggard, reflecting weaker sentiment across global real estate.

As part of the fund's ongoing optimisation, we have introduced the Interactive Equity Prescient Fund as the core local equity holding. This actively managed portfolio focuses on companies trading below intrinsic value or offering strong long-term growth potential. It replaces four previously held mandates, Satrix Top 40, Fairtree Equity Prescient, Prescient Core Top 40, and Prescient Core All Share, allowing for a more focused, valuation-driven approach while maintaining broad sector diversification.

GLOSSARY

Fund of Funds: A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

INFORMATION & DISCLOSURES

The portfolio has adhered to its policy objective and there were no material changes in the composition of the portfolio during the quarter.

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
