The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

## WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to institutional and corporate investors who do not want exposure to non-bank issued corporate debt.


#### RISK INDICATOR DEFINITION



## **FUND COMMENTARY**

Domestically, the SARB maintained the repo rate at 7.0%, in line with consensus expectations, though the decision reflected a split vote of 4–2. The MPC noted that it is assessing the lagged impact of the 125bps of easing delivered thus far, while monitoring inflation expectations and broader risk dynamics before considering further action.

The central bank emphasised uncertainty on the transmission of prior cuts, inflation expectations, and the need to see how rate reductions are feeding through into the economy before loosening further. This statement affirmed that future easing remains the base case, contingent on inflation converging toward the lower bound of the target range.

Markets currently do not anticipate additional cuts this year, with the next cut now priced for Q1 2026.

South African fixed-income markets held relatively firm in September with no material changes in the front end of the curve.

The NCD rates and 3m Jibar rate has held steady with treasury bills offering better yield pick up specifically in the 6 and 9 month area.

We still favour Treasury bills when investing in fixed assets rather than Bank NCDs and continue to add credit conservatively when available in the primary or secondary market.

All asset classes contributed positively towards the month's performance, both the fixed rate exposure and high-quality floating rate corporate assets adding to our above benchmark return.

The Fund delivered strong performance in September, bolstered by positively yielding assets, which contributed meaningfully to the overall return.

There were no detractors over the month.

## **GLOSSARY**

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.
