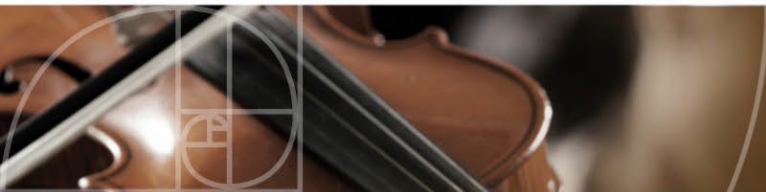

Minimum Disclosure Document & General Investor Report

Investment objective

The Maestro Equity Prescient Fund will be a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, that is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives, the investments to be acquired for the Maestro Equity Prescient Fund, shall comprise a mix of securities, financially sound ordinary shares, stock, financially sound preference shares, debenture stock, debenture bonds and unsecured notes as defined in the Act and the Deed, all to be acquired at a fair market value.

The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index.
ASISA Classification: South African-Equity-General.

Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 31 March 2025, in respect of class A was 2.87%.

Market Overview

Investment markets generally behaved quite well during July, although towards the end of the month things started to “get a bit ugly”. US economic data highlighted the resilience of the consumer. At this stage there doesn’t seem to be much evidence of a rise in prices because of the tariff regime the Trump Administration is pursuing. The latter part of the month was dominated by corporate earnings. There were the usual “good, bad, and ugly” results, but they have been better than most had feared. Some company results, especially large tech ones, were simply brilliant. The MSCI World index rose 1.2% in July while the MSCI Emerging Markets index rose 1.7%. Bond markets were less confident, with the Bloomberg Global Aggregate Bond index losing 1.3%. The latter is still up 5.8% so far this year, which compares to the MSCI World index year-to-date return of 9.9%. Tech companies were the driver of much of the returns, as can be seen in the 3.7% monthly gain in the NASDAQ index. Traditional sectors seen as defensive were under pressure; this much is evident in the Swiss equity market return of -0.7%. The German equity market rose 0.7% and the Chinese market 3.7%, but the Brazil market lost 4.2% as their relationship with the US moved onto rocky ground. US President Trump awarded Switzerland a 39% tariff rate - and that, on their National Day! Perhaps the rate of tariffs is more indicative of the vindictive nature of the President than being based on rational, economic logic.

The US Federal Reserve left interest rates unchanged. This supported the dollar, which has been weak so far this year. The dollar rose 3.4% during the month, trimming its year-to-date loss to 7.9%. Commodity prices ended the month mixed. Platinum group metals had a strong month, the oil price rose 7.2%, the price of iron ore rose 7.7%. Bitcoin rose another 8.5%, bringing its annual gain to 79.4%.

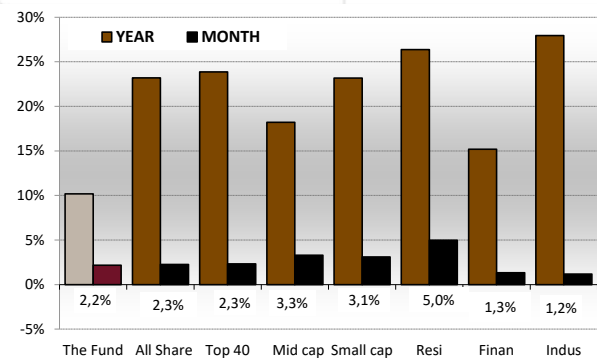

Local market returns

The All Share index rose 2.3% and the All Bond index 2.7%, bringing their respective annual gains to 19.4% and 9.5%. The Basic Material index was again the driver of the gains, rising 5.0% in July, bringing its annual gain to 49.2%. The Financial and Industrial indices rose 1.3% and 1.2%, bringing their respective annual gains to 8.0% and 16.7%. The Large, Mid and Small cap indices rose 2.3%, 3.3% and 3.1% respectively. The rand came under pressure towards the end of the month, in the face of a firm dollar. It declined 1.7%, trimming its gain for the year to date to 4.4%.

Investment Manager comment

The Maestro Equity Prescient Fund rose 2.2% in July, versus the 2.3% gain of the All Share index. Richemont lost 9.6%, Afrimat 3.3%, and Hudaco 2.6%. The MSCI World tracker ETF and Standard Bank each rose 3.8%, Billiton rose 5.6%, the CoreShares S&P500 ETF rose 6.0% and the MSCI US ETF 6.2%.

At the end of June, 8.8% (8.9% last month) of the Fund was being retained in cash.

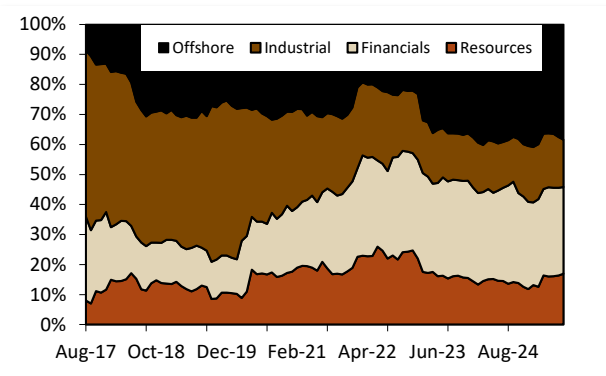
There were no material changes to the Fund's portfolio during July.

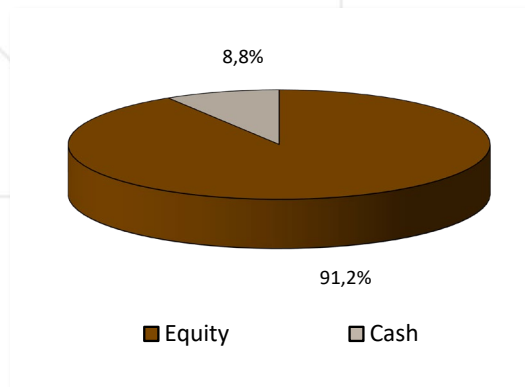

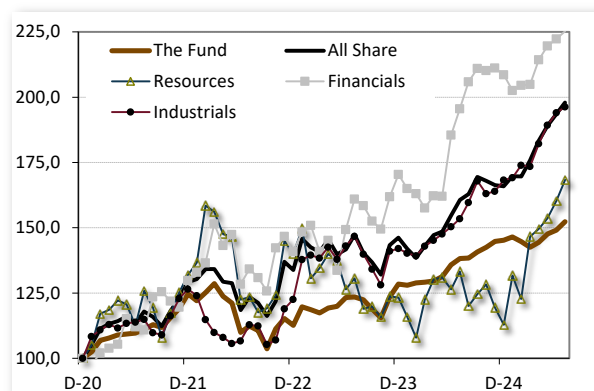
