## FUND OBJECTIVE & STRATEGY

The Fund aims to generate income in excess of money market rates combined with modest capital growth by investing in a range of fixed income assets including cash, NCD's, preference shares, government and corporate bonds and inflation-linked bonds. The Fund may hold listed property and equity, with weightings limited to the sector classification limits. The Fund aims to generate a gross return of CPI plus 1% - 2% over a rolling 12 to 24 month period whilst having a high degree of capital stability.

The average duration of the funds investments will typically be in the range of 2-4 years.

### QUARTERLY COMMENTARY | DECEMBER 2024

The fund delivered 1.4% for the quarter, ending up a pleasing 14.0% for the 12 months (and calendar year). The 12-month performance is ahead of the benchmark (11.8%) and more notably for unit holders, ahead of the fund's overall objective of generating CPI plus 1%-2% over a 12-to-24-month period. SA Bonds were the key driver of this performance, with the ALBI producing a return of 17.2% for the year. The performance of SA Bonds was in stark contrast to global bonds - the World Government Bond Index was down -2.9% in USD over the 12-month period. The key property holdings namely Fairvest, Growthpoint, Redefine, Spear and SAC had a weaker quarter but were all up significantly over the

year Whilst some near terms risks have surfaced globally with bond yields spiking, we continue to see a favorable backdrop for some further compression in domestic bond yields albeit to a far more limited degree than during the 6 months post the formation of the GNU during 2024. Domestic inflation remains well contained (although likely to rise off the current low base) and combined with the objective of stimulating growth in the economy, we still believe that the SARB could cut rates by a further 25 – 50 basis points during 2025.

We made a few changes to the fund during the quarter. These changes were principally aimed at managing the duration and yield of the fund. We completely sold our position in the ABS17 corporate bond and introduced a position in the R2033 bond. We have continued to build on the 2033 position and reduced the position of the R213 and invested additional funds into a combination of the R2033 and R209. In the property sector we trimmed our position in Growthopicit and introduced and position in Hammerson. Using cash on hand we bought additional NCD exposure in the 12m and 18m maturity range. We believe that the current asset allocation is well positioned to meet the funds' stated objective of generating real returns of CPI plus 1%-2%. The duration of the fund is 2.8 years with a gross running yield of 8.95%. During the quarter, the fund paid out a distribution of R3.4 m for Q4 (2.2 cents per unit).
