








# EQUITY SECTOR ALLOCATION (LOOK THROUGH)

During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER

NAV: The net asset value represents the assets of a Fund less its liabilities.

**Positive Months:** The number of individual 1 month periods during the specified time period where the return was not negative

**Maximum Drawdown:** Maximum loss in a peak-to-trough decline before a new peak is obtained, quoted as the percentage between the peak and the trough.

**Fund of Funds:** A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.
