Objective

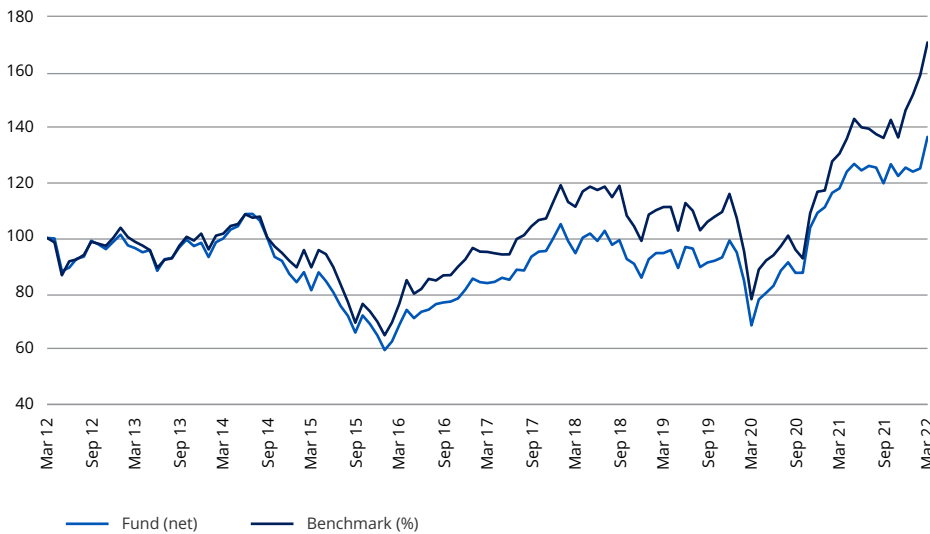
The Fund aims to achieve a combination of income and growth by investing in companies listed on global stock exchanges.

The Fund aims to outperform the S&P Global Natural Resources Index (USD) benchmark (before charges).

Portfolio securities

- The Fund invests at least two-thirds in equities and equity related securities of companies active in the extraction, production, processing and trading of chemicals, building materials, metals and other raw materials, timber and paper products, containers and packaging as well as companies in the energy resources sector, listed on global stock exchanges.
- The Fund has adhered to its policy objective.

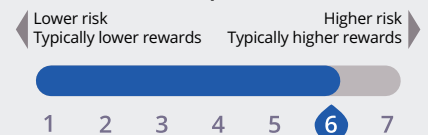

- The Fund is actively managed.

During the phase in period TER's do not include information gathered over a full year.
