



FUND COMMENTARY

The Dynamic Fund continued to deliver consistent investment returns in Q1 of 2024, building on its strong performance base. The Fund has a high exposure (over 60%) to global investment markets. With global equities rising strongly over the quarter and the Rand weakening, the Fund performed well. Our investments in the Old Mutual Global Equity fund and the 10X Total World Stock Feeder fund also added value over the quarter. The Fund is well-diversified with exposure across asset classes and regions.

The global economy remains resilient, with projected real GDP growth in the US of 2.1%. The market envisioned a soft-landing scenario in the US, which drove equity markets higher. The MSCI World index was up almost 9% in USD, mainly driven by technology stocks in the USA, while developing countries added only 2.4%.

Locally, our equity and bond markets experienced declines and were down more than 2% over the quarter. Despite this, we have seen a strong recovery in resource counters since March.

In the coming quarter, South Africans will be heading to voting stations to cast their votes in the most contested election since 1994. Various diverging outcomes scenarios are being tabled, ranging from very bad to very good with the stakes remaining high.

We continue to diversify your assets across asset classes, regions and sectors, considering not only returns, but risks as well.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any I year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.
