The Fund aims to deliver attractive, risk-managed returns through exposure to the South African bond market, while outperforming the All-Bond Index (ALBI).

INVESTMENT PROCESS

The Fund invests in South African bonds, inflation-linked bonds, money market instruments, credit instruments, interest-bearing securities and financial instruments. Apart from assets in liquid form, the Fund may also invest in portfolios of collective investment schemes or other similar schemes. The Fund achieves the investment objective by seeking enhancement opportunities by focusing on cost-effective and financially sound quantitative techniques through a portable alpha process.

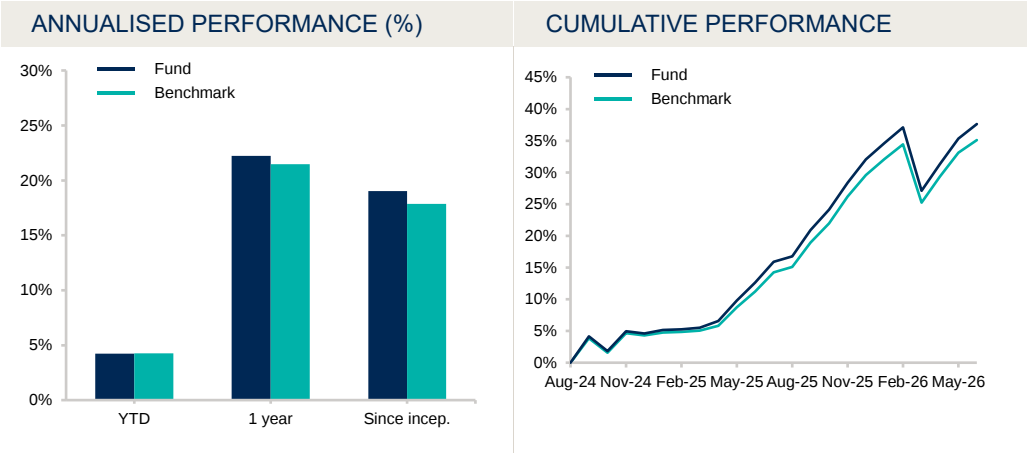
WHO SHOULD INVEST

Investors looking for systematic exposure to the bond market, where alpha is generated from uncorrelated sources. This Fund is Reg. 28 compliant.

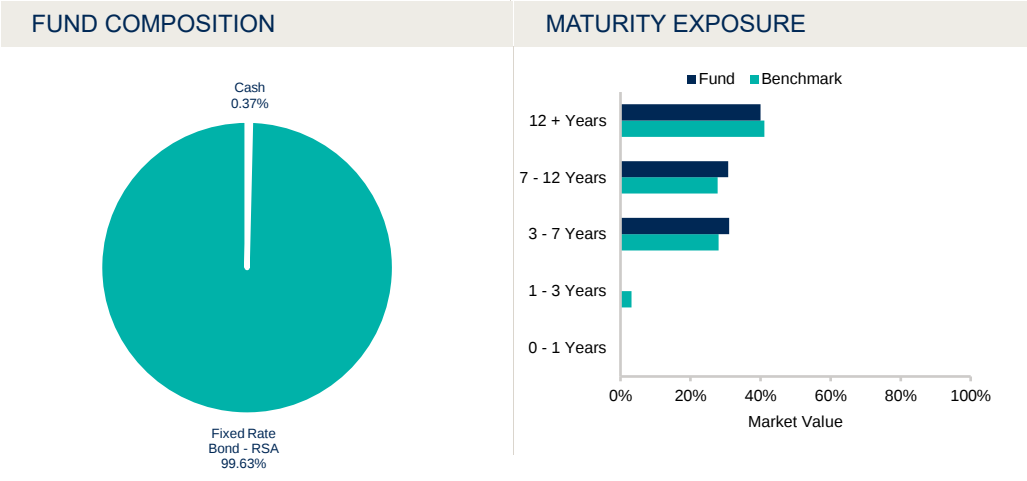
RISK INDICATOR DEFINITION

These portfolios aim to minimise benchmark relative risk. While there may be occasional capital volatility, it is expected to align with the fluctuations experienced by the benchmark. These portfolios are managed in such a manner that the probability of capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.

FUND COMMENTARY

On the global front, the U.S. Federal Open Market Committee (FOMC) held the federal funds rate unchanged at 3.50%-3.75% at its June meeting, the first chaired by Kevin Warsh. While rates were left on hold, the updated dot plot delivered a hawkish shift, with the median projection now pointing to a hike by year-end. 17 of 18 participants viewed inflation risks as tilted to the upside, largely reflecting the energy shock stemming from the Middle East conflict. Encouragingly, the conflict showed meaningful signs of de-escalation over the month, with a conditional ceasefire holding and the parties signing a memorandum of understanding in mid-June.

Locally, May CPI accelerated to 4.5% year-on-year, up from 4.0% in April and its highest level since July 2024, with core inflation rising to 3.8%. The acceleration was driven almost entirely by fuel, with the transport category climbing to 9.4% year-on-year, while food inflation continued to ease. Survey based inflation expectations also surprised to the upside, with the BER's Q2 survey showing a broad-based increase across all horizons, particularly among businesses and labour unions. While the survey predates the sharp decline in oil prices following the easing of Middle East tensions, the rise in inflation expectations is likely to reinforce the SARB's cautious stance and supports the case for another 25bp rate hike at the July MPC meeting.

South African bond yields continue to react to pricing impulses driven by geopolitical developments, central bank actions, and their effects on global financial conditions.

For some emerging economies, high risk-free policy rates, combined with a strong dollar and weaker demand from advanced economies, could increase capital outflows—particularly for commodity importers facing higher commodity prices and weaker exchange rates.

These pressures could pose significant challenges, especially for borrowers with currency mismatches between their assets and liabilities, potentially leading to a heightened "risk-off" environment.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
