INVESTMENT AND RETURN OBJECTIVE

The underlying Fund aims to generate real return in US Dollars and is benchmarked to the US inflation rate, converted to Rands.

INVESTMENT PROCESS

The investment universe includes fixed, floating, real and nominal money market and bond market investments, property, derivatives and global currencies. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, the use of derivatives and currency management.

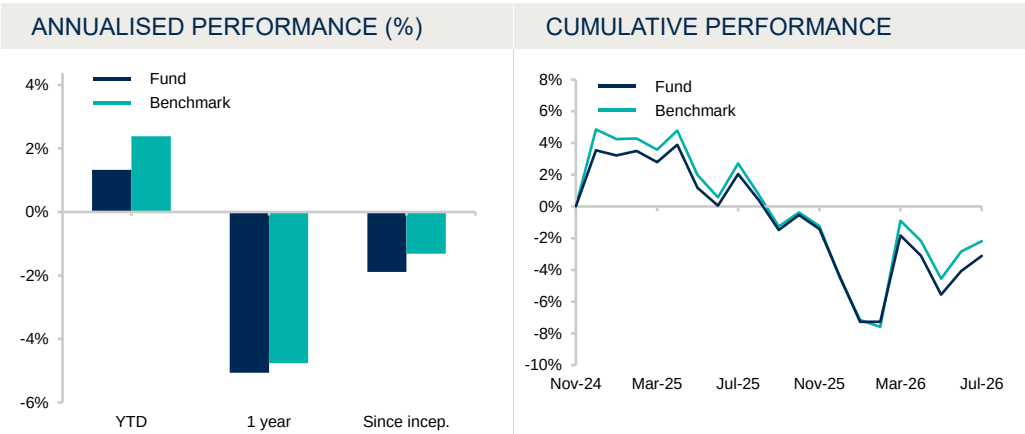
WHO SHOULD INVEST

Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally in South Africa. Although this is a roll-up fund and does not distribute income, it is suitable to investors with a medium to long-term investment horizon who wishes to fund income withdrawals by redeeming units, due to the exposure to yield generating assets held in the Fund and therefore a lower probability of selling underlying units at inappropriate times such as in a market downturn.

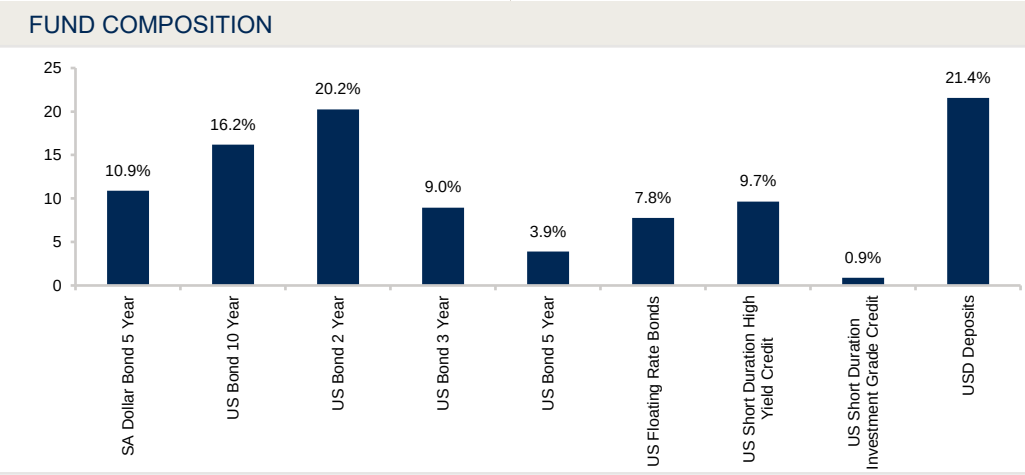
RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

FUND COMMENTARY

Global fixed income during July was dominated by the collapse of the US–Iran détente. The June ceasefire broke down over control of transits through the Strait of Hormuz — a dispute rooted in competing readings of the memorandum's safe-passage provisions — and by mid-July the confrontation had escalated militarily: the US resumed strikes on 13 July, hitting 80 targets and reimposing oil sanctions, while the IRGC claimed attacks on 85 US sites across the region. The supply-risk premium that had drained out of the oil price in June came flooding back, Brent rising roughly 24% over the month from about \$72 to near \$90 per barrel (close to +48% year-to-date), reviving the stagflationary impulse that had gripped markets earlier in the year.

Developed-market rates repriced accordingly.

The Fed held the funds rate at 3.50–3.75% on 29 July, but the meeting was unusually divided — a 9–3 vote with three regional presidents (Hammack, Kashkari and Logan) dissenting in favour of a hike. Chair Kevin Warsh struck a pointedly hawkish tone, stressing the Fed has “no tolerance” for elevated inflation and that “five-plus years of inflation above target cannot be cured in nine weeks.” The US 10-year yield rose about 27bp to 4.71% and the 30-year pushed above 5.20%. Notably, risk appetite rotated rather than capitulated: the S&P 500 finished roughly flat while the Nasdaq 100 fell 6.6%, as capital moved out of technology and into energy and value.

The Fund's emphasis on high-quality carry and short-dated credit again served it well through the volatility, with limited duration exposure containing mark-to-market swings as core yields backed up. With the Fed debate reopened on the hawkish side, energy prices re-escalating and the truce broken rather than merely fragile, positioning remains conservative — favouring yield capture over directional rate risk, while retaining the flexibility to add duration should the supply shock fade and disinflation reassert itself into the second half.

Consistent with its objective of avoiding capital loss over rolling 12-month periods, the Fund remains positioned to navigate uncertain conditions while retaining the flexibility to allocate capital opportunistically as dislocations arise. Overall positioning remains balanced, prioritising capital preservation, stable income generation, and the ability to capture opportunities as global rate cycles evolve through 2026.

The Fund's forward yield remains attractive at 4.98%, with an interest rate duration of 2.42 years. The portfolio's current risk profile aligns with the Fund's risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Feeder Fund outperformed the underlying fund due to the Weakening of the ZAR during the month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Bid Price: The price a buyer is willing to pay for a security.

Offer Price (Ask Price): The price a seller is willing to accept for a security.

Bid/Offer Spread: The difference between the offer and bid prices, indicating market liquidity.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
